Hi Anna,

They can absolutely modify the rake tows as they want. The protocol we followed was one that I developed, and it is an 'official' DNR protocol. Dropping the number of rake tows to 3 for medium visibility reduces the probability of detecting an invasive to 70% for a small patch of plants. You're still very likely to hit a large patch and about 55% probability for an individual plant. We did 5 b/c we didn't want to drop below 80% probability of detection. But sometimes we felt like we were taking continuous rake tows, and it definitely *felt* like overkill.

Hey Kelly

I have a couple questions about implementing the Pond survey method. Milwaukee county has been using it to moni their park lagoons. It seems that they are having problems with the high number of rake tows they have to do and we wondering if they could multiply the medium visibility by three. Below is the email they sent me. If you have any idea or if you could give me a call and we could discuss this issue that would be great. Thanks

Can you also see if it is okay for us to multiply medium visibility areas by 3 rather than 5 to get the # c rake tows needed (at least in ponds 5 acres or less). If we follow your equation it requires us to do a cr amount of rake tows/ring for the size ponds they are. Say we have a 2 acre pond with medium visibilit and we decide we need 2 rings so that would require us to do 50 rake tows/ring (which is very difficult a rowboat).
