As per the order approving the Purple Loosestrife and Eurasian Water Milfoil Monitoring Plan for the Petenwell - Castle Rock Project (FERC Project No. 1984-078) issued on January 22, 2003, Wisconsin River Power Company (WRPCO) is submitting the survey results for purple loosestrife and Eurasian water milfoil.

Petenwell and Castle Rock were surveyed for purple loosestrife from July 21, 2003 to July 25, 2003. The presence of purple loosestrife was identified on Petenwell, mostly on the northern end. All colonies that contained 1-5 purple loosestrife plants were cut and sprayed with an aquatic herbicide after identification. Purple loosestrife was not identified on Castle Rock. A map indicating the location and colony size of the purple loosestrife is located in Appendix A.

An Eurasian water milfoil survey was also conducted the week of July 21, 2003 to July 25, 2003. Surveys were completed at 5 different sample points where Eurasian water milfoil was identified on the water surface. The location of the sample points can be found on the maps under Appendix A. Results from the Eurasian water milfoil surveys can be found in Appendix B.

On October 23, 2003 the results of these surveys were sent to the U.S. Fish & Wildlife Service and the Wisconsin Department of Natural Resources. Documentation of submittal can be found under Appendix C (appendixes not included). At the time of this letter, neither agency has commented on the results.
