Papoose Bay is listed in the Wild Rice Inventory as one of 2 locations on Rest Lake that contain wild rice. It has been recognized by GLIFWC, DNR, and the Papoose Bay Riparian Owners Association. The latter being the group who has submitted mechanical harvest permits for the past 10 or more years, which DNR and GLIFWC have always worked with them to maintain navigation lanes. Lisa David (GLIFWC) is the one who had concerns as to why we did not include Papoose Bay in the ASNRI layer for wild rice (letter below).

Below are comments developed by GLIFWC's Aquatic Plant Management Review Team for Papoose Creek/Bay, Vilas County. Lisa David (<u>lisa@glifwc.org</u>) is the contact if you require anything further on this matter.

It appears that the lake association is aware of, and has incorporated, more restrictive cutting and removal language into the ongoing management at Papoose Bay. Again, this language will better protect the manoomin resource by limiting the width of individual navigation corridors and the center corridor. Additionally, it is important to continue the practice of terminating at the "T" intersection of the center navigation corridor and cut channels 1 and 8 (the furthest east navigation lanes) and not extending all the way to Hwy K.

Lastly, can you address the reasoning behind not including this portion of Papoose Creek/Bay in the PNW-ASNRI wild rice areas or the ASNRI outstanding and exceptional lakes classification on the Rest Lake ASNRI and PNW map that was included in the permit? This omission should be corrected, especially in light of the fact that this is where the manoomin is located. With this correction Papoose Creek from Rest Lake to Hwy K will be considered a priority water.



Hi all,

I didn't get the attached map, but I assume you're referring to the north end of Rest Lake, where Papoose Creek flows into the lake?



Here it's a question of where does Papoose Creek end, and Rest Lake begin? The ASNRI wild rice layer uses the 24k hydro cutoff. A wild rice remapping/designation review project has been ongoing for quite some time, so I'm hesitant to change the areal extent without input from wild rice staff (Kevin Gauthier) and/or the water management specialist (Kyle McLaughlin), especially since it looks like a number of riparian property owners up there could be impacted.

As for making an actual update, wild rice waters are stored in SWIMS as ROIs, so the update would simply be creating a new ROI for that polygon.
