In accordance with the Federal Energy Regulatory Commission (FERC) Order Modifying and Approving Purple Loosestrife and Eurasian Milfoil Monitoring Plan for the Grand Rapids Hydroelectric Project, dated January 2, 1998 and the Order for the Comprehensive Monitoring Report and Future Plan for Eurasian Watermilfoil for the Grand Rapids Hydroelectric Project dated May 15, 2012, Wisconsin Public Service Corporation (WPS) is required to provide monitoring reports of the purple loosestrife (PL) and Eurasian water milfoil (EWM) surveys to FERC by December 31 each year a survey has been completed.

2018 Purple Loosestrife Survey Results

A survey for PL was completed on July 19, 2018. No PL was observed during the survey. Appendix A includes the 2018 PL survey results. The next PL survey is scheduled for 2019.

2018 Eurasian Water Milfoil Survey Results

EWM surveys are to be completed once every three years, with the next survey scheduled for 2020.

Per the Michigan Department of Natural Resources (MDNR) comments on the 2017 PL and EWM Report, WPS plans to add a new EWM transect to the Michigan boat landing during the next scheduled survey in 2020. WPS installed new invasive species signage, provided by the MDNR, at the two Grand Rapids boat landings located in Michigan.

A copy of this report was submitted to the Wisconsin Department of Natural Resources (WDNR), MDNR, and the US Fish and Wildlife Service (FWS) on October 31, 2018. The WDNR, MDNR, and FWS did not provide any comments. Appendix B includes the 2018 documentation of consultation.


