1.0 SUMMARY

Aquatic Invasive Species (AIS) monitoring and watercraft inspections began on June 1, 2021 and were completed on August 31, 2021. Yellow Iris, Chinese mystery snail, Rusty Crayfish, Aquatic-Forget-Me-Not, Purple Loosestrife, and Non-Native Phragmites were observed in 2021.

Rooted Curly-leaf pondweed was not observed for the fourth year in a row. All known locations of CLP were visited and systematically searched and with no presence of CLP during the 2021 survey.

During the survey, no new locations were discovered to contain Purple Loosestrife (P.L.). Eleven (11) existing sites were observed to have young plant at those locations. Those plants were pull and properly disposed of.

Yellow Iris was present throughout the project boundaries. During the 2015 survey locations were noted with GPS locations and mapped to detect any increase of decrease of populations. During the 2021 survey the Yellow Iris was observed to be in 141 locations. There was no change in population locations from the survey of 2020 to 2021. Many locations observed during the 2021 survey had more individual plants than noted during 2020. Many locations had much more robust plants than in the past years.

Chinese mystery snails have been previously noted and in 2021 were located within the entire project boundaries. The largest populations were noted in the upper river portions.

Rusty crayfish were also found throughout the project boundaries and have been previously noted to be in the system.

Eurasian watermilfoil was not observed during any of the surveys in 2021 and it has not been previously reported within the project boundaries.

Aquatic Forget-Me-Nots were first observed in 2013 and placed on the restricted list by the state of Wisconsin in 2015. Ten location were observed in 2016 and marked with GPS locations to

further monitor population increases or decreases. During the 2021 survey Aquatic Forget-Me-Nots showed no increase in locations observed.

Phragmites was noted by a private property owner within the project boundaries. The site had been previously noted and monitored for five years during surveys with no growth in occupation of shoreline. Samples have been taken and sent in for genetic testing at University of Wisconsin Whitewater for determination of species in 2018. The genetic sampling resulted in a positive identification of nonnative Phragmites. The genetic sequence however showed that it was a cultivated species that suggests it may have been planted for decoration. The location was treated with herbicide buy a licensed applicator during the 2019 field season to remove the plants. In 2021 again limited growth reappeared and was planned to once again be addressed by county partners and the landowner. No other locations were observed during the 2021 field season.

Watercraft inspections were completed during the 2021 season with limited interaction due to Covid 19 issues.

Japanese Knotweed Reynoutria japonica was observed on a property owners' shoreline within the boundaries of the project area. The population is currently being addressed by Wisconsin Headwater Invasive Partnership. The population was not in the waterway but rather up on the bank of the property. Special attention should be used when surveying this area in the future. No observed locations in 2021.

2.0 Introduction

The Rhinelander Flowage is comprised of Boom Lake, Bass Lake, Thunder Lake and Lake Creek and extends through Tomahawk, Newbold, Pine Lake, and Pelican townships in Oneida County. The Rhinelander Flowage was formed when a mud and timber dam was constructed on the Wisconsin River in 1882. In 1903, the present dam was constructed for the purpose of generating power for the new paper mill (IMFWisconsin, 2013). Aquatic invasive species (AIS) were first documented in the Rhinelander Flowage in 2006 with the discovery of rusty crayfish and purple loosestrife. It is possible that both species were present prior to that and just not reported.

AIS are of concern because they can threaten the balance and diversity of a water body. AIS tend to be aggressive, altering habitat in which they invade and can out-compete native species for

food and shelter. They can create recreational issues that become a nuisance to the public. AIS can also have economic impacts, as much money and labor can be spent monitoring and mitigating their impacts (McFarlane 2012).

The Federal Energy Regulatory Commission license for the operation of the Rhinelander Flowage dam pertaining to article 406 requires the licensee to file an invasive species management plan to monitor species such as, purple loosestrife, Eurasian watermilfoil and other possible invasive species (Appendix 1). The invasive species management plan requires the licensee to conduct annual surveys for AIS and file annual reports with the Federal Energy Regulatory Commission.

Activities to meet requirements as listed in the plan could include:

- Watercraft inspections
- AIS monitoring
- Public education and involvement
- Updating signage as needed
- Aquatic plant surveys
- AIS mapping
- AIS removal
- Other AIS related activities

The activities during the 2021 survey included the following:

- 1) Monitor existing AIS populations, which include Curly-leaf pondweed, Purple Loosestrife, Rusty crayfish, Aquatic Forget-Me-Nots, Non-Native Phragmites and Chinese mystery snails.
- 2) Search for new AIS, to include Eurasian watermilfoil, zebra mussel and spiny water flea
- 3) Perform watercraft inspections

4) Control existing AIS populations as appropriate

3.0 Project area

The Rhinelander Flowage is a soft water drainage system having slightly alkaline, clear water of low transparency. Sand is the predominant littoral material (75 percent) with muck (23 percent) and extremely limited area of gravel. The shoreline is predominantly upland with wetland of shrub type adjoining portions of the flowage; a good development of wild rice exists in the upper end (Andrews, 1966).

There are eight boat landings throughout the Rhinelander Flowage. Five landings are located along the upper portion. The Town of Pike has three of them, two off River Rd and one along Journeys End Rd. The Town of Newbold has two, one off Surf Rd and the other off Apperson Dr. There is another public boat landing on Boom Lake in Hodag Park. Lake Creek has a landing off River Rd and Bass Lake has one access point off Moon Lite Bay Rd (Appendix 3).

The upstream and downstream survey limits for the Rhinelander Hydroelectric Project were defined as follows.

- The water and shoreline of the Rhinelander Flowage from N45° 44' 10.1", W89° 31' 08.4" WGS84 to approximately 0.5 miles upstream from the McNaughton Road Bridge to the dam at the Rhinelander Hydroelectric Project.
- The waters and shoreline of the power canal bypass reach, and tailrace from the dam at the Rhinelander Hydroelectric Project downstream to N45° 38' 12.4", W 89° 25' 0.00" WGS84 approximately 400' downstream of the Davenport Street Bridge.
- Waters and shoreline of Boom Lake, Bass Lake, Thunder Lake and of Lake Creek; up to the confluence with the stream from South Pine Lake at 45° 40' 24.5" W 89° 24' 57.5" WGS84 (Appendix 3).

4.0 Methods

4.1 Meandering survey

A meandering survey consists of driving a boat slowly along the shoreline of a lake between shallow water and maximum rooting depth of aquatic plants or 100 feet from shore, whichever comes first. Rake throws: D-nets, snorkeling, aqua scopes, and underwater cameras can be used as necessary to aid in searching for AIS during a meandering survey.

4.2 Early detection survey (Primary method utilized)

This is a baseline lake-wide AIS monitoring survey with standard operating procedures - see Appendix 4. This protocol is the basis for the surveys conducted within the project boundaries. Adaptations on the survey to best suit the conditions and species have been added. Three complete surveys are conducted with a grid like approach within regions of previously known species presence. These surveys are completed within timeframes of highest probability of species observations. Example: Early June a complete survey is done with primary emphasis on Curly leaf pondweed, due to its early emergence. July, Yellow Iris is mapped due to blooming time and easiest species verification. August, Purple loosestrife is mapped due to bloom and verification. Within all completed survey periods full protocol is completed and all other findings would be documented.

4.5 Watercraft inspections

Watercraft inspections are performed by a trained individual at a boat landing. See Appendix 5 for specific inspection methodology. All data is collected on Form 3200-120.

4.6 Vouchering

All newly discovered AIS have specimens collected and sent to an appropriate laboratory for verification. Vouchering protocols can be found in Appendix 3, voucher collection protocol, page 34.

5.0 Results

Curly-leaf pondweed, purple loosestrife, Phragmites, aquatic forget-me-not, yellow iris, Chinese mystery snail, rusty crayfish and Eurasian watermilfoil were monitored using meandering and early detection survey methods. The meandering survey was completed by from June 1st, through August 31, 2021.


5.1 Curly-leaf pondweed

Curly-leaf pondweed was not located within the project boundaries in 2021. All previously known locations were revisited and checked, no rooted CLP was located.

5.2 Purple loosestrife

Purple loosestrife was observed in eleven (11) previously known locations of the Rhinelander Flowage during the 2021 survey. Eight (8) plants were observed at locations on Creek Lake and Thunder lakes, locations were observed in 2017 and plants were pulled at that time. Two new locations were observed in 2018 and again in 2020. Two (2) plants were observed in the marsh region of the upper flowage and the one (1) below the dam downstream. All plants were pulled and disposed of. GPS data was taken and mapped to assist with future management of the Purple loosestrife.

Figure 3: Purple Loosestrife




***Upper river location of Purple loosestrife 2021

5.3 Aquatic forget-me-not



Aquatic forget-me-nots were first documented in 2013 and will be continued to be monitored. Aquatic forget-me-not were added to the Wisconsin invasive species restricted list in 2015.

Figure 6: Locations of Aquatic Forget-Me-Not



5.4 Spiny waterflea

Spiny waterflea were monitored using waterflea survey methods. The survey was completed on August 28th, 2021, with five sites being sampled during survey for the presence of spiny waterflea (Figure 6). Site 1 and 2 are within the river system and furthest north. Sites 3,4, and 5 are contained within boom lake. Samples taken at sites 1 and 2 were net tows and water samples. Sites 3,4 and 5 sites were completed with Eckman dredge and sediment samples. After collection, samples were analyzed for the presence of Spiny waterflea following standard laboratory protocol and Wisconsin DNR standard operating procedures. No spiny waterfleas have been detected in surveys completed during the 2021 monitoring season.

5.5 Zebra mussel

Zebra mussels were monitored using veliger survey methods. Three sites were sampled on August 8th, 2021 (Figure 7). Samples were analyzed in a laboratory for presence of absence utilizing state lab protocol. Table 5 lists information collected as part of the sites sampled. No zebra mussel veligers were detected during the 2021 sampling season.

5.6 Yellow iris

Yellow Iris was observed throughout the project boundaries in 2021. Utilizing the mapping and GPS points that were collected during the 2016 season, there showed no increase in the number of locations of Yellow Iris within the project boundaries during 2021 surveys. Locations where it had been observed during the 2020 season it remained and no new locations were observed during the survey. There was a slight reduction in population with some physical removal being done by local stakeholders.

Rusty crayfish were observed throughout the project boundaries in 2021 and were known to be present previously.

5.9 Eurasian watermilfoil

Eurasian watermilfoil was not observed during any surveys in 2021 and has never been detected within the project boundaries

5.10 Watercraft inspections

Inspections were completed this year one a limited basis during the monitoring season due to Covid-19 Coronavirus and the social distancing parameters set forth at a statewide level. 45 hours of monitoring was completed with 119 people contacted.

5.11 Phragmites

A location within the project boundaries was observed to contain a Phragmites population. This population has been noted and measured for the last five years while the survey was performed. During the 2018 survey samples were taken and tested for genetic makeup but the University of Wisconsin Whitewater. The results of the genetic test proved it to be a Nonnative Phragmites, but the genetic sequence also proved it to be a cultivar. This suggest that it may have been planted for decoration at one time. The stand was treated with herbicide by a licensed applicator during the 2019 survey season to remove it from the shoreline. During 2021 survey once again, regrowth was noted in the current location. Treatment was once again scheduled to remove the population. No other locations were observed during the 2021 season.

ORDER AMENDING INVASIVE SPECIES MANAGEMENT PLAN PURSUANT TO ARTICLE 406

(Issued May 11, 2011)

On February 10, 2011, Wausau Paper Specialty Products, LLC (licensee), filed a request to amend the invasive species management plan for the Rhinelander Hydroelectric Project (FERC No. 2161), pursuant to article 406 of the project license.1 The project is located on the upper Wisconsin River in Tomahawk, Newbold, Pine Lake, and Pelican townships, Oneida County, Wisconsin.

BACKGROUND

Article 406 requires the licensee,2 after consultation with the Wisconsin 2. Department of Natural Resources (Wisconsin DNR) and the U.S. Fish and Wildlife Service (FWS), to file an exotic species control plan to monitor invasive species, such as purple loosestrife (Lythrum salicaria) and Eurasian water milfoil (Myriophyllum spicatum), at the project. The approved invasive species management plan, as modified, requires the licensee to conduct annual surveys for invasive plants, especially purple loosestrife and Eurasian water milfoil, in project lands and waters, for at least five consecutive years.3 The approved invasive species management plan requires the licensee to file annual monitoring reports with the Wisconsin DNR and FWS for review, and to file the annual monitoring reports, with any resource agency comments and recommendations, with the Federal Energy Regulatory Commission (Commission). licensee filed the five annual monitoring reports with the Wisconsin DNR and FWS, and subsequently with the Commission, in a timely manner.

- 3. The approved invasive species management plan requires that the fifth monitoring report be a comprehensive report containing a comparison of all data collected in the previous five years. Further, it states that if, after five consecutive years, there appears to be either no invasive plant species present or no spread of existing invasive plants, then the licensee may propose an alternative monitoring and reporting frequency, after consulting with the resource agencies.
- 4. The licensee filed its fifth monitoring report on December 10, 2010, which documented the survey of project lands and waters for invasive species for 2010. The licensee filed its comprehensive summary report separately on February 10, 2011, along with its request to amend the plan.

LICENSEE'S SUMMARY REPORT

- 5. In 2006, a baseline meander survey for purple loosestrife and Eurasian water milfoil was conducted for the project. Annual surveys were conducted in 2007, 2008, 2009, and 2010. During all of the surveys, no Eurasian water milfoil was found. In addition, point intercept surveys for Eurasian water milfoil were performed concurrently with the meander surveys, in all survey years at the project, and no Eurasian water milfoil was found.
- 6. In all survey years, purple loosestrife was found within the limits of the project, both upstream and downstream of the project dam. The total number of occurrences and plants has remained relatively low during the five years of surveys:
 - 2006 one occurrence (16 plants) located in the upstream (impoundment) and eight occurrences (28 plants) downstream (bypass reach and tailrace) of the dam (total = 44 plants)
 - 2007 two occurrences (14 plants) located in the upstream and five occurrences (25 plants) downstream of the dam (total = 39 plants)
 - 2008 two occurrences (12 plants) located in the upstream and nine occurrences (40 plants) downstream of the dam (total = 52 plants)
 - 2009 five occurrences (20 plants) located in the upstream and four occurrences (28 plants) downstream of the dam (total = 48 plants)
 - 2010 nine occurrences (35 plants) located in the upstream and eight occurrences (23 plants) downstream of the dam (total = 58 plants).

Overall, the number of purple loosestrife plants observed downstream of the dam has remained about the same while those upstream of the dam have shown an increase. The licensee cites the use of the Galerucella beetle as a biological control and the ability of the survey crew to remove the seed heads or to pull many of the plants from licensee-owned and/or publicly-accessible lands downstream of the dam. The licensee cites the absence of the Galerucella beetle and the difficulty in obtaining permission from land owners to enter their property to remove the plants upstream of the dam.

LICENSEE'S PROPOSED AMENDMENT

- 8. The licensee proposes, after consultation with the Wisconsin DNR, to provide funding to the Wisconsin DNR to hire a seasonal summer employee from mid-May through August. This person will be directed by the Wisconsin DNR and their duties would be focused both on control and monitoring of purple loosestrife in the project area. The licensee proposes that the seasonal employee's activities would include:
 - watercraft inspections
 - Aquatic Invasive Species (AIS) monitoring (Eurasian water milfoil, curly leaf pond weed, purple loosestrife, spiny water-flea, zebra mussels, and possibly others)
 - public education and involvement
 - updating signage as needed
 - aquatic plant surveys
 - AIS and aquatic plant mapping
 - AIS removal
 - train volunteers on watercraft inspection and citizen volunteering monitoring activities
 - other AIS related activities as needed.
- 9. The licensee proposes to fund this position for a period of five years. At the end of the five-year period, the licensee proposes, in consultation with the resource agencies, to review the effectiveness of this procedure in the control of purple loosestrife and other invasive species. The licensee states that the funding of the AIS person would be a valuable contribution in the control of invasive species, and that the funding would provide a more effective and coordinated use of funds to enhance the quality of the project area.



Aquatic Invasive Species Early Detection Monitoring in Lakes

State of Wisconsin Department of Natural Resources STANDARD OPERATING PROCEDURES

Bureau of Water Quality March 2015

BACKGROUND

The Wisconsin Department of Natural Resources (DNR) currently relies upon a strong network of volunteers (Citizen Lake Monitoring Network – CLMN), partners (e.g. Wisconsin River Alliance, Great Lakes Indian Fish and Wildlife Commission, University of Wisconsin-Madison, County AIS Staff) and Department staff to monitor lakes and streams for new aquatic invasive species (AIS). This system has been adequate to date but does not enable a statewide assessment of AIS presence/absence or the rate of spread and therefore an evaluation of the effectiveness of the State's AIS message which is aimed at stopping the spread of AIS by targeting transient boaters.

The statewide monitoring strategy outlined below will provide DNR and partners with information to:

- 1. Establish baseline data on statewide AIS distribution.
- 2. Track the rate of AIS spread in several vulnerable waterbodies that will represent the state.
- 3. Evaluate the effectiveness of outreach and education efforts aimed at stopping the spread of AIS.

In addition to these three priority objectives this monitoring strategy may trigger statewide, regional or local implementation of a rapid response strategy, lead to an assessment of abundance and frequency within a waterbody and/or an evaluation of management activities. These secondary monitoring activities will depend on staff and funding availability and will likely be funded through competitive projects and AIS or other grants or by DNR partners.

To have a statistically valid assessment of AIS spread in the state's lakes the DNR is monitoring 200 randomly selected lakes per year over a 5-year period. At the end of the five years the Department will be able to say with statistical validity what the rate of AIS spread is within the state and whether that rate of spread increased or decreased by as little as 3% annually or if it stayed the same.

Monitoring will be conducted by WDNR staff, partners, and volunteers. The statewide AIS monitoring coordinator (Ferry) will develop monitoring protocols and coordinate monitoring efforts. The three Great Lakes Basin AIS Specialist's (Bates, Nault, and Plude) are specifically hired to conduct monitoring and response in counties that touch the Great Lakes Basin. Regional DNR AIS coordinators and staff will implement monitoring in non-Great Lakes basin counties (NORc-Hansen/Kreitlow, NORr-Gauthier,

NORs-Toshner/Smith, SCR-Graham and WCRProvost/Lepsch). The Great Lakes Indian Fish and Wildlife Commission, county AIS staff and Citizen Lake Monitoring volunteers will help where appropriate.

Voucher Collection Protocol

- Collect specimens of <u>all observed</u> invasive plants, invertebrates, and didymo for verification and QAQC purposes.
 - Collect up to 5 intact specimens of plants from each lake. Place aquatic plants in a ziplock bag with a small amount of water and riparian/wetland plants in a bag with a wet paper towel. Try to get the root system, all leaves as well as seed heads and flowers when present.
 - Collect up to 20 individuals of Dreissenids and store in a sample bottle or Ziploc bag.
 - Collect up to 3 of other invertebrate species observed.
- While in the boat, store specimens in separate sample bottles or in Ziploc bags with water or a wet paper towel.
- Upon completion of the survey, specimens should be properly preserved. Plants should be vouchered once per week and animals should be preserved daily.
- See *Vouchering Preparation and Shipping* section below for appropriate vouchering protocols for each type of species and the location to send specimen.
- Record data on the Early Detection Form.




Figure 1. Schematic of AIS Early Detection Survey Design (Latzka and Van Egeren 2010). This map does not accurately illustrate tows and has additional water quality information that is not collected during these surveys.

- Survey all public boat landings (public and commercial). Do not include small, backyard boat ramps. Record the location of each boat landing from the shoreline in decimal degrees using a GPS (datum WGS84) whether any AIS are found.
- Each landing is searched for 30 minutes using snorkeling, D-nets, rakes, and surveying shoreline. Snorkel for 15 minutes covering an area of shoreline 200' long out to the maximum depth of plant growth or 100' from shore. For distance reference, baseball bases are 90' apart and a football field is 300' long. Spend 15 minutes using the D-net and rake in the shallow water and examining the shoreline for 200'.
- For QAQC purposes, collect specimens of all AIS recorded.
- If there is poor visibility or safety is a concern (e.g. blue-green algae bloom), do not snorkel. Instead, analyze rake tows and D-net samples for about 30 minutes within the defined area (200' shoreline and 100' from shore). □ Record data on Early Detection form.

Waterflea Tows

• Collect 3 oblique waterfleas tows using a ~250-micron mesh net from the deep hole according to the Water Flea Monitoring Protocol:

http://dnr.wi.gov/lakes/forms/protocols/SpinyWaterflea MonitoringProtocol.pdf.

- In shallow lakes, it is difficult to collect oblique tows. If possible, collect 3 horizontal tows. If the water is too shallow with dense macrophytes, attempt collecting 3 vertical tows, but avoid collecting macrophytes. Indicate on the data sheet comments if you could not collect a waterflea tow.
- Rinse samples into the sample bottle and decant as much water as possible. See the Voucher Preservation and Shipping section for instructions on preservation and labelling.
- Record data on Early Detection Form and also the Water Flea Tow Monitoring Report form 3200-128: http://dnr.wi.gov/lakes/forms/3200-128-waterflea.pdf.

Veliger Tows

Revised Veliger Tow Protocols

- Variations from the established Dreissenid (Zebra and Quagga) Mussel Monitoring Protocol include using conductivity to determine whether veliger tows are conducted and locations and depths within lakes to be sampled.
- Lakes with a conductivity of 99 umhos/cm or greater must be sampled for veligers. Historical conductivity records for some lakes are included in the lake list spreadsheet.
- Collect 3 vertical zebra mussel veliger net tows (using the 64-micron mesh net); one from the deep hole and 2 other tows from deep areas along the downwind side of the lake.
- Veligers are plankton and will move with the wind so sample deep, downwind portions of a lake. In lakes that stratify, veligers will be in higher abundance above the thermocline so samples should be collected slightly deeper than the established protocol indicates. Since most staff do not have dissolved oxygen probes to determine the depth of stratification, we have included estimates for sampling depth below.
- The depth of the veliger tow will depend on the depth of the water using the following criteria:
 - 1) if water column is deeper than 6 meters (~19.7 feet), then collect each tow with the ring of the net 4 meters (~13.1feet) from the surface; or
 - 2) if the water column is shallower than 6 meters (~19.7 feet), attempt to collect a vertical tow with the ring of the net within 2 meters of the bottom.
- The net must be lowered slowly to not disturb the bottom sediments and get sediment in the net. Rinse samples into the sample bottle and decant as much water as possible. □ Record data

on Early Detection Form and the Mussel Veliger Tow Monitoring Report (http://dnr.wi.gov/lakes/forms/3200-135-veliger.pdf). See Voucher Preservation and Shipping for instructions on preservation and labelling.

Targeted Search Sites

- Stop at each targeted search site and conduct 10-minute snorkel searches. If there are two people, one person should snorkel for 5 minutes while the other person examines the shallows and shoreline for 5 minutes (while also keeping watch on the snorkeler). If you find additional appropriate search sites during the shoreline meander, you can add additional 10-minute searches or replace the sites that you pre-selected.
- For QAQC purposes, collect specimens of all AIS recorded.
- If there is poor visibility or safety is a concern (e.g. blue-green algae bloom), do not snorkel. Instead, at each site analyze rake tows and D-net samples for about 10 minutes.
- Record the site number and location (center of site at shoreline in decimal degrees) of each site on the datasheet whether any AIS are found. Record the name of any species found and density rating (as defined on the datasheet). Record data on Early Detection Form.

Meander Survey

- During the meander survey, drive boat slowly between target sites and look for aquatic invasive plants, mussels, and snails in the water and along the shoreline. Meander between shallow water and maximum rooting depth or 100' from shore whichever comes first.
- If not snorkeling the target sites due to poor visibility or safety concerns, visibility will likely be difficult during the meander survey also. To sample during the meander survey in low visibility, collect 50 rake tows/D-net samples during the meander survey.
- Record the site number, location in decimal degrees and the name and density (as defined on the back of the datasheet) of each AIS occurrence observed. However, only collect separate GPS points from discretely different beds or populations of invasive species.
- If three discrete locations of a certain species are found either at targeted search sites and/or during the meander survey stop recording new locations during the meander survey. Three discrete locations of one species will indicate that the species is established in the lake.
- Collect specimens of all AIS reported for QAQC purposes.
- Record data on Early Detection Form.

Appendix 4. Watercraft inspection protocol

Watercraft Inspections

Materials to Have When Working at a Boat Landing

Not all your materials need to be taken to the boat landings. It is better to sort through the materials and decide what educational information is best suited for your area. The "Clean Boats, Clean Waters" program provides a plastic container in which to store all the educational materials in the resource kit. We recommend at least one resource kit for every landing you are monitoring. By using multiple resource kits, each inspection team can have all the materials they need and have them protected from the weather.

A key brochure to distribute to all boaters is "Help Stop Aquatic Hitchhikers" (WT-801). This brochure not only has pictures of the different aquatic invasive species, but also describes the prevention steps that boaters need to take every time they leave the water. In addition, the brochure describes Wisconsin's illegal-to-launch law and the penalties that can occur if an invasive species is not removed before the boat is launched. This brochure is a good reminder to all boaters, whether they have talked with a watercraft inspector.

Select other materials to take to the boat launch based on which aquatic invasive is most threatening in your area. Perhaps Eurasian watermilfoil is really a pressing issue for your lake; then it makes sense to give boaters an EWM/NWM identification card in addition to the "Help Stop Aquatic Hitchhikers" brochure. Resist the temptation to give the boater one of every card in the resource kit because boaters will often discard them. It is best to start by handing out a little bit of information and have additional brochures available if the boaters want to learn more about a particular invasive species.

Boat landings can be terribly busy during the summer, and it is expected that you will need more materials. Watercraft Inspection Tips

Use the following DO and DON'T lists to prepare your boat landing message.

The DO List

- Wear the "Clean Boats, Clean Waters" Tshirt to promote the message. This message gives credibility to the
- Try to approach boat owners before they are on the ramp.
- Always ask if the boater would mind answering a few questions.
- Be polite and courteous to all boaters you encounter.
- Listen to a boater's concerns. Remember that you are encouraging boaters to take an interest in invasive species.
- Make sure boaters know that they can make a difference!

The DON'T List

- Do not begin asking questions immediately upon approaching boaters, because as they might be confused about who you are and why they should give you their time.
- Avoid delaying boaters too much or causing a backup.
- Never preach to a boater; your mission is to educate, not alienate.
- Do not emphasize the idea that fines are involved, because this approach can make people hostile or defensive.
- If the boater is reluctant to cooperate, hand out educational material and record whatever information you can.

An effective watercraft team is prepared to raise boater awareness and to encourage and demonstrate the necessary steps to avoid spreading invasive species. On rare occasions, you may be uncomfortable about a situation or person. Always back away from a potentially dangerous or violent situation. Never encourage confrontation, no matter how strongly you might feel about the subject. Remember, you are not enforcers of rules and should never jeopardize your own safety. If you are suspicious of someone (for example, a loiterer or someone who is not intending to go boating), do not hesitate to leave the launch site. You are better to be safe than sorry. If you feel that a boat launch site is unsafe in any way, please notify the organization you are working for.

Boat Landing Message

Getting out and speaking to the public can be intimidating. New inspectors can feel a little anxious and nervous. This prepared script will help inspectors' practice and role-play before their first boater shows up at the landing. Practicing with other folks will give them the confidence it takes to greet a boater. If new inspectors really want to watch a "pro," they just need to ask a few kids to get involved. Are kids intimidated? No way!

This prepared script is only one sample of the many methods of addressing boaters at the landings and performing watercraft inspections. Each inspector should develop his or her own style and learn how to adapt in a variety of boat landing experiences. Try to approach boaters before they are on the ramp and

use the Watercraft Inspection Report form to record the information about the boater (see Section 7). At times you may have only 30 seconds to talk to the boater; other times, long lines at the landings may provide you with lots of time to talk. Remember, if the boater is not interested, just hand out educational material and record whatever information you can.

No matter what style you use to approach boaters, any watercraft inspection process should include these points:

- 1. Tell them who you are, whom you represent, and why you are there.
- 2. Ask if they have a short time to answer some questions.
- 3. Collect information on the Watercraft Inspection Report form.
- 4. Ask if they are familiar with aquatic invasive species, such as Eurasian watermilfoil or zebra mussels. Briefly explain about these invasive species or other invasives found locally.
- 5. Ask if they will join you in an inspection of their boat and equipment.
- 6. Talk while inspecting and point out watercraft checkpoints. If they do not want to assist you in the inspection, continue to talk about invasive species as you inspect.
- 7. Give your final message, the prevention steps:

Inspect your boat, trailer and equipment and

Remove any attached aquatic plants, animals, and mud.

Drain all water from your boat, motor, bilge, live well, bait containers, and equipment.

Dispose of unwanted bait in the trash, not in the water or on the land.

Rinse your boat and recreational equipment with hot water OR dry for at least five days.

- 8. Give them the "Stop Aquatic Hitchhikers" decal and other educational materials.
- 9. Thank them for their time and cooperation!

Sample Script

As the boat approaches, write down the time of the boat inspection and if the boat is entering or leaving the water.

Introduce yourself:

Good Morning / Afternoon. I am from _____. We are working with state agencies and local groups to talk with boaters about invasive species and help them check their boats for Eurasian watermilfoil (EWM) and zebra mussels (ZM). We are trying to keep EWM/ZM and other harmful exotics from spreading from lake to lake. I have a few quick questions I would like to ask you, and then I would like to walk around your watercraft with you and point out a few places where these species can attach to boats and trailers.

Ask the questions and record on the Watercraft Inspection Report:

- 1. In the past 30 days, how many times have you been contacted by a watercraft inspector?
- 2. Was boat used during the past 5 days on a different waterbody? (If the answer is yes) Where?
- 3. In a typical month of boating, about how many waterbodies do you visit?

- 4. Last time you went boating, please describe the steps you took when removing your boat from the water. (Mark each step that is mentioned, "Took No Steps" if no steps were taken, or "I Did Not Ask Boater" if this question was not asked.)
 - 5. In 2009, Wisconsin laws were passed that prevent the transport of aquatic plants, animals, and water from one waterbody to another. This includes draining water from containers holding your catch and livewells. Were you aware that this is the law?

(If the answer is no) As of 2009, Wisconsin laws prohibit the transport of plants, animlas, or water from a boat landing. Fines for not complying with the rules can be upwards of \$300! I am just here to share information with you on how to properly clean your boat so that you don't inadvertently transport aquatic invasive species from one lake to another. However, law enforcement officers will be out enforcing these AIS laws this summer, so I just wanted to let you know about the new rules.

Perform a watercraft check:

If you would walk around your boat with me, I can show you some areas to look for invasive hitchhikers.

Make sure you talk aloud as you inspect; it helps reinforce the "Clean, Boats, Clean Waters" behavior. Talk to boaters about inspecting and cleaning their watercraft and about draining the water from their boat—such as the bilge, bait buckets and live wells—before they leave the access.

Water is another way invasives can move from lake to lake, so it is always a good idea to drain your water. Vegetation can be found on motorboats, the motor/prop, anchors, bunks, rollers, the trailer axle, lights/wiring; for jet skis, it can be found in the intake grate and propeller; and for sailboats, it can be found in the centerboards. Check your anchor and anchor line to see if any plants are clinging to it.

Some aquatic invasives, such as zebra mussels, are also found on the motor/prop, on the sides and bottom of boat below the waterline, on the anchor, and clinging to vegetation. It is a good idea to drain water from the motor, live well, bait well, bait bucket, bilge, and transom wells. Always inspect the hull and sides of your boat for aquatic invasives; if it feels gritty or sandy, it may be that new zebra mussels are attached

An extra precaution that you can take to eliminate other aquatic invasives is to wash your boat with warm tap water or take your boat through a car wash or dry your boat and equipment in the sun for five days before entering another lake.

Leave boaters with a final message: "Clean Boats = Clean Waters"

Please make it a habit to:

Inspect your boat, trailer and equipment and

Remove any attached aquatic plants, animals, and mud.

Drain all water from boats, motors, live wells, bait containers, and equipment.

Dispose of unwanted bait in the trash, not in the water or on the land.

Rinse your boat and recreational equipment with hot water OR dry for at least five days.

Offer boaters the "Stop Aquatic Hitchhikers" brochure and decal and help them place the decal on the handle side of the trailer winch post. Tell them that this decal will let other inspectors know that you have talked to the boater this summer. Remind boaters to follow the precautions listed on the "Stop Aquatic Hitchhikers" decal every time they leave a water body.

Thank the boaters for their time and cooperation!

Potential Scenarios/Questions from Boaters

"Why are you out here wasting resources when the plant is going to come anyway?"

Even the most educated will ask this question. Just be prepared mentally for such viewpoints and think about why you are out here and what you will say in reply. Expect the unexpected. Here are some suggested responses:

Even if we cannot keep the plants out completely, we can prevent a lot of widespread damage. Prevention also gives us time to adopt new control methods as they are developed in the future. The longer we keep invasives out of a lake, the longer we put off the enormous costs of management and property devaluation.

"Aren't all plants bad anyway?"

It is important to clear up this misconception! This is what you can say:

Native plants are essential lifelines for an aquatic ecosystem, providing the basis for all life within. The problem lies with non-native, invasive plants that have no natural inhibitors and, therefore, outcompete native plants, lowering the water body's aquatic diversity.

"I don't have time for this... I know all about it already!"

This remark is common. If the boaters do not wish to help you with the survey, you must

respect their rights and let them be. In such a situation, the suggested action would be to offer them a brochure and wish them a nice day.

"Why did it take Wisconsin so long to do something, when milfoil has been a national problem for over a decade?"

There is no good answer to this question because it is a very good point. Here is how you can respond:


Traditionally, environmental problems become established before we do anything about them. In this case, we have learned from other states, and are trying to act well before these plants spread to many of our sensitive environments. Instead of focusing on what could have been done, we should focus energies on the present and future.

"Why do I have to take these prevention steps when I only use my boat in one lake?"

This question gives you the opportunity to talk about the value of changing our behaviors and why it is important.

That is a great question! Although you always visit the same lake, it is still useful for you to take these prevention steps every time you boat. Repeating these steps helps the actions become a regular part of your boating behavior, so that if you do ever decide to take your boat to another lake, you will remember to take the prevention steps. Prevention is the key to stopping the spread of aquatic invasive species.

How to Handle Violations

With thousands of boaters traveling throughout the state and with many of those boaters jumping from lake to lake within one day, it is very realistic to expect someone to try to launch a weed-filled trailer at your landing. Since 2001, it has been illegal to launch a boat or trailer with aquatic plants or zebra mussels attached, and in 2009 it became illegal to transport aquatic vegetation or water from one place to another, in addition to other AIS laws (see Section 3 for more details). Not all folks know about Wisconsin's AIS laws. Even after several publications, news articles, and television programs concerning invasive species, not all boaters realize the importance of their action or lack of action in preventing the spread. Keep in mind that you should first try to educate the public.

If you choose to report launching violations, make sure you have done your homework. Contact your local DNR Conservation Warden and local law enforcement to let them know that you will be doing inspections. Ask if they are willing to provide you with support in the case of a violation, what information is necessary for enforcement, and more importantly, ask whether the enforcement officer will be willing be act on a violation if he or she has not witnessed the event. Knowing these answers before the event will certainly predict a better outcome.

So, what happens when a boater violates an AIS law? Several options can occur, from the least offensive reaction to the strongest objections to remove and comply with the law.

The soft touch: Boaters who are unaware of the AIS laws will probably put the boat in the water and think nothing about it. Unfortunately, this has been the practice for many years, which is one reason Wisconsin is struggling to control the spread of aquatic invasive species. However, you have an opportunity to educate that boater about the dangers of invasive plants and the prevention steps that boaters need to take each time they leave a body of water. With luck, boaters will listen to your message and remove aquatic plants and drain all water without any assistance.

An assertive approach: So, what do you do if a boater does not get the point? Offer to assist the boater in checking and removing any aquatic plants. Always ask permission first before you touch any boat, trailer, or personal equipment. If the boater gives you permission, go ahead and help remove the plants and ask if you can keep a sample, especially if you suspect an invasive species. Let the boater know that you're just trying to prevent them from receiving a citation from any law enforcement or wardens that stop by, because the wardens are stepping up the number of citations, they're issuing for AIS violations.

The strongest approach: And what if the boater refuses to remove the aquatic plants or drain water from their boat and equipment? At this time, you really stress the fact that it is illegal to not comply with the prevention steps that you're recommending, and you use the Violation Report form to record the basic information that a law enforcement officer requires in order to pursue the complaint. If you take a picture, it should include the boat registration number and attached plants. Usually, by this last step, the boater complies, the plants come off the boat, and the lake remains safe from another invasive inoculation.

If the boater chooses to launch after all your efforts, then you can report the facts to a law enforcement officer. The definition of "law enforcement officer" for purposes of section 30.715 (4), Wisconsin Statutes, is noted at section 30.50 (4s), Wisconsin Statutes, which reads:

30.50 (4s) "Law enforcement officer" has the meaning specified under s. 165.85 (2) (c) and includes a person appointed as a conservation warden by the department under s. 23.10 (1).

Section 165.85 (2) (c), Wisconsin Statutes, in turn defines "law enforcement officer" as any person employed by the state or any political subdivision of the state, for the purpose of detecting and preventing crime and enforcing laws or ordinances and who is authorized to make arrests for violations of the laws or ordinances that the person is employed to enforce.

The definition of "law enforcement officer" is obviously very broad and would clearly allow law enforcement officers of counties and municipalities throughout the state to enforce the AIS regulations and laws. Your best resource is your regional DNR Water Guard or local DNR Conservation Warden. Before you pursue any enforcement action, contact your local warden to know what information the warden expects from you. The warden will decide how to process the violation.



We are excited to now have DNR Conservation Wardens devoted primarily to providing education and enforcement on the AIS laws and regulations. Each DNR region in Wisconsin has at least one Water Guard; in some cases, more than one.

Appendix 6

Water Flea Monitoring Protocol

Based on water fleas monitoring protocol developed by Pieter Johnson, UW – Madison Limnology Department - April 2006.

Annually the DNR staff selects water bodies to sample for water flea infestations. This protocol is designed to assist DNR staff in collecting samples, shipping, reporting and how the information is released for public knowledge. Using this protocol will standardize the collection techniques, improve the quality of collected samples, limit the number of contaminated samples and ensure an accurate water flea infestation database.

Water Flea Monitoring

Sampling Equipment:

- Boat/Anchor
- 0.5-1-meter diameter, 250-micron mesh plankton net
- Rope on net with the meter increments marked
- Vinegar/Large container to hold plankton net for vinegar bath
- 250 ml plastic bottles
- 1-liter plastic bottles

- Alcohol, 95% alcohol (190 proof ethylalcohol)
- Lake Maps
- Sharpie/Labels for Bottles
- Water flea data collection sheet
- Cooler with ice
- Change for car wash (you may want to make a map of the car wash stations in your area) |
- GPS unit

The Department updates the water flea listing annually after sampling results are compiled and then issues a press release listing those waters infested with water fleas and other invasive species. The Department issues a second press release and list prior to the opening of the fishing season reminding boaters to take precautions to avoid spreading spiny waterfleas and other invasive species. A current water flea infestation map can be found at this website: http://dnr. wi.gov/invasives/aquatic.htm

Spiny water fleas (Bythotrephes longimanus) are large (up to ¾ inch), predatory crustacean zooplankton native to parts of Europe and Asia. They have been established in all the Great Lakes since 1992 and have begun moving into inland lakes in Ontario, Minnesota, Ohio, Michigan and, most recently, Wisconsin. Outside of Mysis shrimp, spiny water fleas are considerably larger than any naturally occurring lake zooplankton. They are readily distinguished by their long tail spines, which generally support between one and three barbs. Fishhook water fleas (Cercopagis sp.) are another predatory crustacean zooplankton known to have invaded the Great Lakes. At this time, however, their movement into inland lakes has been limited primarily to upstate New York. Both spiny and fishhook water fleas are often first noticed by anglers and recreational lake users. These invasive water fleas tend to become entangled on fish lines, anchors, downrigging cables, and other types of gear used in boating activities. Extreme care should be exercised to avoid transporting these organisms among lakes.

Sampling:

Frequency

Three samples should be collected from a particular lake on three dates between June and September (for a total of nine samples per lake). Ideally, samples should be collected at monthly intervals after the water temperatures reach 54 degrees. The first collection dates will vary from early to late June. If you choose not to sample the same lakes on each of the three sample periods, please contact the analytical lab so that they can make the appropriate changes to the database.

Sample Location

On each sampling date, water flea samples should be collected from three different locations in a lake. The sites should be in different bays or basins or at several of the more heavily used lake sites. The three sampling sites should be deep enough to sample, so perhaps in 15 to 20 feet of water is a good rule of thumb. Ideally, the deepest point of the lake and areas near boat landings (sites of boat traffic) or lake's outlet are the best locations to sample. Shallower lakes can be sampled as well by making more of a horizontal tow so as not to disturb the bottom of the lake. Mark on the lake map where samples were collected. These same sites should be used for each of the sample periods – if not, then submit a revised map with subsequent samples.

Collection

- 1. Collect sample with a large diameter (0.5-1-meter opening) zooplankton net with a mesh size of 250 microns. Smaller nets can easily clog with small forms of phytoplankton and zooplankton and can allow spiny water fleas to elude capture.
- 2. A 100-meter horizontal tow is best suited for capturing water fleas. A GPS unit (to measure distance and/or rate of travel) can be used or tow the net for 120 seconds at a low boat speed (~3 km hr-1) that prevents the net from surfacing (horizontal tows are facilitated by adding weight to the zooplankton net; tie a loop in the rope approximately 0.5-1 meter in front of the net and attach a weight (e.g., a brick with a hole in it) using an additional piece of rope or cable tie). Ideally, horizontal tows should be oblique (Figure 1), sampling from the top of the thermocline to just below the water's surface. Care must be given that the net does not hit the lake bottom. When this happens, the sample is of muddy water, which is very difficult or impossible to analyze. If you hit the lake bottom, rinse out the sampling equipment and go to a different area of the lake that will provide enough depth for a good tow.
- 3. Be sure to rinse the net from the outside of the net so that all the material washes into the plankton collection cup. If water fleas are present, they will likely be visible immediately within the collection cup (but not always).
- 4. Record sampling information on the water flea collection data sheet.
- 5. Decant your plankton sample into a 250 ml sample bottle after each tow.

- 6. Condense the size of the sample by filtering out as much water as possible in the field. This helps reduce the amount of alcohol that needs to be added and aids in the analyses as well.
- 7. Preserve the sample using 95% alcohol. The ratio should be 4 parts alcohol to 1-part sample. Note: If the prescribed alcohol to sample ratio (4:1) cannot be achieved after repeated condensing and decanting, then the sample should be split between two sample bottles. Label each with the same information (as specified under "Processing the Sample -Field"), and label one as "Split 1 of 2" and the other as "Split 2 of 2".
- 8. Repeat the process at the other two preselected sites. Composite the samples from the three sites into one 250-ml or larger (1-liter) bottle and receive a single enumeration for the lake. Note: If samples are shipped by common carrier, size restrictions may apply to the sample containers. The maximum size

- allowed under the US DOT regulations for plastic containers is 1 liter check with the shipper for any additional restrictions prior to sampling so that samples are collected in appropriately sized bottles.
- 9. Transport the sample bottle(s) on ice in a cooler.
- 10. Local laboratory identification of waterfleas can be conducted by the region water quality biologist. Spiny and Fishhook Waterflea Watch and Wild cards are excellent resources for identification. Shipping Samples:

Water flea samples, preserved with ethanol (4 parts ethanol: 1-part sample), are hazardous materials because of their flammability (the flash point of a 4:1 ethanol/water solution is

approximately 72º F). Any staff preparing specimens for shipment MUST attend a hazardous training workshop. These workshops are offered annually at the spring watercraft inspector meeting. The certificate of completion is good for three years.

It is mandatory that we use the State Spee-Dee Delivery contract to send samples within Wisconsin, unless they are not available in your region. Decontamination Procedures:

When multiple lakes are sampled on the same day, the net, boat and all other sampling equipment must be decontaminated between lakes. Decontaminating will eliminate cross contamination and reduce the risk of transporting invasive species from lake to lake. You do not have to decontaminate equipment between sample sites on the same lake. If multiple lakes are sampled in one day, it is recommended to sample any lakes that are not on the watch or infestation lists before sampling lakes on those lists, to minimize the potential for transport

gear may be damaged by disinfection solution and should only be rinsed with clean water. For other gear used in water choose one of the following options:

Option one: The gear can be sprayed with the disinfection solution and a wet surface maintained for the appropriate contact time. The gear should be rinsed with clean water or water from the next waterbody before it is used again.

Option two: Fill a tub with disinfection solution and place all equipment in the tub for the appropriate contact time. The gear should be rinsed with clean water or water from the next waterbody before it is used again.

Option three: Use a completely new set of gear for each waterbody during the workday and disinfect all gear at the end of the day using option one or two.

** If water fleas are observed, extreme care should be taken to avoid transporting individuals. We recommend that you use a different net if you have additional lakes to sample or discontinue sampling for that day to allow for sufficient decontamination if you do not have another net.

Regardless, it is a good idea to rinse your equipment in hot water and let the net and cup dry thoroughly for at least 24-48 hours after a day of sampling, both to preserve the integrity of the net and reduce the risk of any resting eggs remaining viable.

- You should wash the boat between lakes following the DNR boat cleaning procedures. Please refer to the agency guidelines at the beginning of this Section of the handbook.
- Another approach that has been quite effective in some areas is to benefit from citizens that offer to take our technical staff onto the lake with their boats. This saves time because we do not have to launch and then decontaminate the trailer and boat upon departure.

Listing Guidance

The Wisconsin Department of Natural Resources is monitoring some of our inland waters for the presence of water fleas. This guidance document provides listing recommendation criteria for when to place a water body onto the Infested List. A review team consisting of the statewide and regional AIS staff

makes the final determination for listing a waterbody.

DNR lists a waterbody as infested for water fleas when we have data indicating that there is an established reproducing population. Lakes that are hydraulically connected to waterbodies infested for water fleas are placed on to the Water Flea Watch List. Nearby waterbodies that are not hydraulically connected may also be put on to the Watch list-based recommendation by the area biologist and decision of the Exotic Species Coordinator and review team.

Notification/Rel easing Water Flea Information

Standard Notification Sequence:

Following the Water flea listing criteria cited above, the regional biologist and the statewide coordinator have concurred that the waterbody should be listed. The regional biologist informs the Public

Information Officer (PIO), wardens, fishery and water resources staff, volunteer monitors, and management at the regional level about the sighting. The regional staff, in consultation with the statewide coordinator, determines if a press release is needed. Prior to issuing a press release, the regional biologist notifies the local entities affected by the sighting (lake association or district and industries or water utilities). Attached, as an addendum to this report, is a sample press release that can be used as a template. After the press release is issued, the regional biologist coordinates any follow-up actions that are necessary including posting signs, additional monitoring, or information and education (I&E)/outreach efforts.

Since 1992, the Great Lakes have been infested with Water fleas and now the spiny water fleas are moving into inland lakes in Ontario, Minnesota, Ohio, Michigan and most recently, Wisconsin. Spiny water fleas are a small shrimp like animal that grows to an average of 0.4 inches in length and feeds on other small animals. Although spiny water fleas are tasty to fish, it is protected from small fish predators by an unusually long tail spine. Fish feeding on spiny water fleas have great difficulty ingesting the tiny zooplankton. Spiny water fleas can have a profound effect on the fish population because it feeds on
the zooplankton that small fish depend on for survival. "There are prevention steps that everyone should take when boating, fishing and otherwise enjoying the water that can help prevent the spread of invasive species,"
Before moving your boat/equipment to a new waterbody:

- Inspect and remove plants, animals, and mud from your boat and equipment.
- Drain all water from your boat's live wells, bilge, motor, etc.



- Do not move live fish away from a waterbody.
- Dispose of your unwanted bait in the trash. Use leftover minnows only under certain conditions.
- Rinse your boat and equipment with high-pressure and/or hot water OR
- Dry your boat and equipment thoroughly for at least 5 days.

Apendix 7

Dreissenid (Zebra and Quagga) Mussel Monitoring Protocol

Annually the DNR staff selects over 100 water bodies to sample for zebra and quagga mussel infestations. This protocol is designed to assist DNR staff in collecting samples for adult and veliger (larval form) Dreissenid mussels. Additionally, this protocol provides guidelines on how the zebra and quagga mussel information is reported and how the information is released for public knowledge. Using this protocol will standardize the collection techniques, improve the quality of collected samples, limit the number of contaminated samples and ensure an accurate zebra mussels infestation database.

The Department updates the zebra mussels listing annually after sampling results are compiled and then issues a press release listing those waters infested with zebra mussels and other invasive species (including quagga mussels). The Department issues a second press release and list prior to the opening of the fishing season reminding boaters to take precautions to avoid spreading zebra mussels and other invasive species. Sampling:

Sample Frequency

Three samples should be collected from a particular lake on three dates between June and September (for a total of nine samples per lake). Ideally, samples should be collected at monthly intervals after the water temperatures reach 54 degrees. The first collection dates will vary from early to late June. If you choose not to sample

the same lakes on each of the three sample periods, please contact the analytical lab so that they can make the appropriate changes to the database.

Sample Location

On each sampling date, veliger samples should be collected from three different locations in a lake. The sites should be in different bays or basins or at several of the more heavily used lake sites. The three sampling sites should be fairly close to hard substrate (i.e. habitat such as rocks or piers) but deep enough to sample, so perhaps in 15 to 20 feet (4 to 6 meters) of water is a good rule of thumb. Avoid collecting the veliger sample from an open-water deep mid-lake site. Additional samples can be taken in bigger bodies of water where there may be multiple fingers, bays, or multiple boat launches. Mark on the lake map where samples were collected and optionally collect GIS coordinates. These same sites should be use for each of the sample periods – if not, then submit a revised map with subsequent samples.

Sample Collection

The volume of water that you sample can generally be determined by the trophic status of the lake. A highly eutrophic lake will quickly fill the net-bucket with plankton and provide a dense enough sample to examine for veligers. However, an oligotrophic lake requires sampling a greater volume of water to collect a sufficient sample. Using the standard plankton net (50-cm diameter*, 64-micron mesh) the volume of

water to collect for the different trophic conditions are:

- Oligotrophic lakes (Secchi > 4m) collect two 2-meter tows from each site.
 Consolidate to 1 sample for each site. You will have sampled 4-meters of water per site.
- Mesotrophic lakes (Secchi 2-4m) collect one 2-meter tow from each site. You will have sampled 2-meters of water per site.
- <u>Eutrophic lakes</u> (Secchi < 2m) collect one 1-meter tow from each site. Samples from eutrophic lakes are more difficult to analyze, so reducing the sample volume will facilitate the process. You will have sampled 1-meter of water per site.

*note: if using the 30-cm diameter net, you should sample five 2-meter tows for oligotrophic lakes, three 2-meter tows for mesotrophic lakes and three 1-meter tows for eutrophic lakes to obtain relatively the same volume of water as above.

Lower the net into the water at the first of the three pre-selected sites. Pull the net up vertically. Care should be taken to pull the net up slowly enough so that no pressure wave is created on the surface of the water. If you are creating a pressure wave, you are undersampling the water column. Be sure to rinse the net from the outside of the net so that all the material washes into the plankton collection cup. Record sampling information on the zebra mussel data collection form (see appendix 1).

• Care must be given that the net does not hit the lake bottom. When this happens, the sample is of muddy water, which is



very difficult or impossible to analyze. If you hit the lake bottom, rinse out the sampling equipment and try shorter tows (e.g. two 1-meter tows instead of the protocol of one 2-meter tow), or go to a different area of the lake that will provide enough depth for a good tow.

- For shallow lakes where it is impracticable to do a vertical tow, collect a horizontal sample at middepth. In shallow lakes, you may split the sampling depth (i.e., two one-meter tows with the 50-cm net or five one-meter tows with the 30-cm net).
- Condense and decant your plankton sample into your bottle after each tow to obtain an accurate enumeration of the larval density in your lake. For example, if you had two 2-meter tows, you would wash down the net from the outside and condense the sample for each of the 2-meter tows. Both samples should be placed into the 250ml plastic bottle or 1-liter bottle. (Use the smallest bottle size that is practical, but you may need to use a 1-liter bottle due to the sample size). Note: If samples are to be shipped by common carrier, size restrictions may apply to the sample containers. The maximum size allowed under the US DOT regulations for plastic containers is 1 liter – check with the shipper for any additional restrictions prior to sampling so that samples are collected in appropriately sized bottles.

- Condense the size of the sample by filtering out as much water as possible in the field.
 This helps reduce the amount of alcohol that needs to be added and aids in the analyses as well.
- Preserve the sample using 95% alcohol. The ratio should be 4 parts alcohol to 1-part sample.

Note: If the prescribed alcohol to sample ratio (4:1) cannot be achieved after repeated condensing and decanting, then the sample should be split between two sample bottles. Label each with the same information (as specified under "Processing the Sample – Field"), and label one as "Split 1 of 2" and the other as "Split 2 of 2".

- Repeat the process at the other two preselected sites. You will have 3 samples for each lake
- Alternatively, you can composite the samples from the three sites into one 250ml or larger (1-liter) bottle and receive a single enumeration for the lake. Obviously, with the composite sampling, you lose specific sample location information, but either approach is acceptable.
- Transport the sample bottle(s) on ice in a cooler.

Shipping Samples Containing Ethanol

Veliger samples, preserved with ethanol (4 parts ethanol: 1-part sample), are hazardous materials because of their flammability (the flash point of a 4:1 ethanol/water solution is approximately 72° F). Ethanol solutions are classified as flammable liquids by the US Department of Transportation and the shipment of such materials is governed by US DOT's regulations - with a couple of exceptions, as listed below.



<u>Transport in State Vehicles</u> Hazardous materials, including ethanol solutions, can be transported in State of Wisconsin vehicles, without the need to comply with any US DOT regulations. Thus, it is permissible to ship these samples by state vehicle. The hazardous nature of the samples is not diminished simply because no shipping requirements pertain to this mode of transport, and some commonsense precautions should be taken when using this means of shipping:

- Samples should be transported on ice to keep them below their flash point temperature.
- Samples should not be kept where hazardous materials would otherwise not be permitted, e.g., in an office.
- Samples should not be transported in the passenger compartment of a vehicle.
- All employees involved in transporting ethanol-containing samples in a state vehicle should be made aware of the hazard that these samples pose and the precautions that should be taken to minimize those hazards.

US Postal Service the US Postal Service has its own set of requirements for shipping hazardous materials, and therefore it is not subject to the US DOT hazardous materials regulations. Guidance for shipping ethanol solutions via the USPS is available on the Intranet at: http://intranet.dnr.state.wi.us/ int/es/science/ls/fpm/EtOH usps.pdf and on website the USPS at: http://www. usps.com/cpim/ftp/pubs/pub52.pdf. The USPS regulations provide a limit of one container (not to exceed 1 pint for a nonmetal container) per mail-piece. Given this limitation, the USPS will generally not be a practical alternative for shipping these samples.

Common Carriers

The US DOT regulations (49 CFR, Parts 171 – 180) apply when shipping samples via common carrier. Many of the familiar shipping companies provide hazardous material shipping service. The US DOT regulations begin with training requirements for those who offer hazardous materials for shipping via a common carrier. Therefore, any staff member who prepares ethanolcontaining samples for shipment via a common carrier must be trained in accordance with the requirements of the US DOT regulations. Additional requirements apply to packaging, packing, marking, labeling and documentation. The regulations are available at: http://www. myregs.com/dotrspa/. Some shipping companies have additional requirements, or more restrictive requirements than the US DOT regulations. Table 1 summarizes some of the basic information about shipping hazardous materials with some of the common shipping companies.

Adult Zebra and Quagga Mussel Monitoring

The adult monitoring serves several purposes:

- to verify a reproducing population if veligers have been identified as being present in a water sample,
- to determine the population densities of mussels after an infestation has occurred,
- to track the spread by collecting additional data on lakes where veliger monitoring is not being conducted, and
- to monitor for the quagga mussel.

Adult Dreissena (zebra and quagga) mussel monitoring for inland waters is accomplished using one of two methods:

- Shoreline surveys and regular inspections of structures in the water to determine the presence/absence of zebra and/or quagga mussels.
- 2. Substrate sampler monitoring (substrate refers to any substance in the water that zebra or quagga mussels may attach to) to estimate population densities.

- Anchor (e.g. concrete block)
- Rubbing alcohol
- Zebra mussel data sheets, Method A and Method B (see appendices 2 & 3)
 - Ż quagga mussel reporting is discussed below and requires lab verification
- Hand lens 30x Method A:

Shoreline Surveys

Shoreline surveys and inspections of structures in the water are conducted to identify the presence or absence of adult Dreissena mussels. A single observer can monitor thousands of square meters of substrate at a given location in a short period of time – covering a larger surface area than a set of substrate samplers. Monitoring for the presence or absence of adult zebra or quagga mussels will address two important objectives: 1) document the presence of adult Dreissena mussels when veligers have been found during the veliger monitoring, and 2) document multiple year classes of zebra or quagga mussels. These data provide important



information regarding the viability of the population of zebra or quagga mussels in that waterbody.


Collecting Samples

- Conduct shoreline surveys about once every two weeks from ice out to ice on.
- Target areas around public boat ramps or areas that are likely to have a lot of boating traffic in the vicinity (for example, fishing hot spots, resorts, campgrounds, etc.).
- Any solid surface is a suitable substrate to observe. Rub your hands along some of the submerged surfaces. Zebra mussels on the surface will feel like sandpaper.
- Zebra mussels are often found in cracks and crevices of rocks and structures. Small zebra mussels can be attached to plants as well (Figure 1).

NOTE: It is especially important to pay attention to structures removed from the water in the fall of the year or before winter ice forms (for example, docks, piers, boats, buoys, etc.)

Reporting Zebra Mussel Monitoring Results

Collect any mussels that you believe are zebra mussels, place them in rubbing alcohol and send it to the zebra mussel regional coordinator for confirmation. See zebra mussel contact list in watercraft inspector handbook. If you find what you believe are zebra mussels and note various shapes of mussels of similar size, collect those as well for evaluation of whether quagga mussels may also be present.

For tracking the movement of zebra or quagga mussel infestations, a negative report is as important as finding Dreissena mussels at a location. All monitoring efforts should be reported on the zebra mussel datasheets and submitted to Ron Martin at 101 South Webster St., Madison, WI 53707. Complete the zebra mussels reporting form Method A, electronically available as form 3200122 A at


Method B: Substrate Monitoring

Substrate samplers can be used to determine if zebra mussels or quagga mussels are present. When placed in waterbodies without known populations of *Dreissena* mussels, substrate sampler monitoring documents the arrival of zebra or quagga mussels and tracks the spread of these mussels. Substrate samplers can also be useful on lakes with known zebra mussel populations for determining zebra mussel population growth and seasonal abundance, and for monitoring for the presence of zebra mussels and quagga mussel.

Substrate Sampler Materials

The sampler is a series of four squareplates that are 6, 8, 10 and 12 inches in size, pyramiding from smaller plates at the top down to larger plates at the bottom (Figure 2). The plates are made of ¹/₈inch grey plastic PVC stock with ¾-inch CPVC grey pipe for spacers (1-inch sections) between the plates. The sampler is held together with an 8inch-long 3/8-inch diameter stainless steel eyebolt, plus washers and a wing nut. Each sampler has a DNR tag attached that provides a phone number for further information. Samplers are ordered from Cathy Cleland (Rhinelander, 715-365-8997). Directions to build a substrate sampler are found in Appendix 4. Note: the substrate samplers are easily disassembled and cleaned for the next sampling season.

Placement of Substrate Samplers

- Place the substrate sampler in an area where there will be little chance of vandalism.
- Hang the substrate sampler from a dock, pier or other structure found in the water. (A float or buoy may be used to suspend the sampler in the water column. If a float is used, a waterway marker application and permit form is necessary before the substrate sampler is placed in the water).
- Put two samplers at each location chosen for monitoring. The top sampler is removed and analyzed every four weeks, then placed back into the lake for the next sampling period. The second (bottom) sampler remains in the water for the entire monitoring season. Securing the two samplers on the same line with clips makes it easy to replace the top one every four weeks.
- A small concrete block anchor works to hold the sampler(s) in place (and provides an additional substrate sampler to examine).
 Rope can be used to suspend the sampler, but sometimes wildlife will sever the rope.
 Chains work well to better secure the samplers in those locations.



- Suspend substrate samplers in water, preferably where the water is at least 6 feet deep, but shallower is acceptable. Samplers should be placed at a depth of 6 feet or at mid-depth, whichever is less.
- Place samplers in areas where zebra mussels are most likely to be found. Pay special attention to areas in which zebra mussels may have been transported from infested waterways (for example public boat ramps, water access sites, fishing hotspots, resorts, from the water.
- campgrounds or areas where diving ducks tend to reside).
- Avoid placing substrate samplers in areas where there is strong current.

Analysis of Samples for Quantitative Monitoring of Adults

- 1. Put the samplers in small white or clear garbage bags when they are removed
- 2. In the lab, disassemble the sampler and examine each plate with a hand lens. Scan the entire plate looking for zebra mussels.
- 3. Recently settled post-veligers can be exceedingly small. If you were to rub your hands along the plate, the surface will feel like sandpaper. If you believe that you have detected post-veligers, please mail them to the Watercraft Inspector to have it examined by the Region Biologist or send it to Jim Steinke following the shipping protocol cited in the veliger monitoring section for verification.
- 4. Count the number of zebra mussels found on the top and bottom of each plate and record these numbers separately. (use zebra mussel Method B forms see appendix 3).
- 5. Report the lengths of the smallest and largest mussels on the plate to the nearest millimeter (1/16-inch). Measure the longest axis of the shell. See diagrams below.






- 6. For an initial discovery, all zebra mussels collected should be placed in rubbing alcohol for expert verification.
- 7. For lakes that have zebra mussels and the monitoring is to detect if the quagga mussels are also present:
 - sort the mussels by relative size and shape,
 - compare the shapes
 - ✓ Zebra mussels (Dreissena polymorpha) have a flat attachment edge, usually a dark striped shell and are almost as wide as it is tall.
 - ✓ Quagga mussels (Dreissena bugensis) have sharp edges on both sides and are fanshaped. The quagga mussel shell is wider and narrower than the zebra mussel. Coloration may range from nearly all white to coloration like the zebra mussel.



- 8. If you believe that you have two differently shaped mussels of the same relative size, place those mussels in alcohol and send them to the Region biologist or Jim Steinke for verification.
- 9. If there are many mussels attached to the plate (Figure 3), a subset of the plate can be evaluated and reported. The sub-sampling method used must be reported on the lab reporting form.

Note: Sampler plates can be thoroughly scrubbed, dried, reassembled and reused next year.

Zebra Mussel Listing Guidance The Wisconsin Department of Natural Resources is monitoring some of our inland

Complete the zebra mussels reporting form Method B, electronically available as form 3200-122 B at http://intranet.dnr.state.wi.us/ itworks/forms/eforms.asp or a paper copy in Appendix 3 below.

Samples should be clearly labeled with all requested information. Both field staff and volunteers that monitor for adults use the same data sheets. For tracking the movement of zebra mussel infestations, a negative report is as important as finding zebra mussels at a location. All monitoring efforts should be reported on the zebra mussel reporting form and submitted to Scott Van Egeren.

Field staff should also provide Scott Van Egeren with a lake map showing the location of the monitoring sites. The zebra mussel monitoring sites, along with the names and addresses of the monitors, are maintained and updated periodically. Maps showing all the sampling locations (for adults and veligers) are recorded on the GIS network and are available on the DNR web page:

mussels using substrate samplers. Occasionally sample results from a lake will detect low numbers of zebra mussel veligers in a sample or very few adult mussels of the same size. In both incidences a zebra mussel introduction has occurred, but these data do not substantiate that a reproducing population exists in that waterbody. Quagga mussels are present in Lake Michigan coastal areas but have not been found in Wisconsin's inland lakes at this time.

This guidance document provides listing recommendation criteria for when to place a water body onto a Watch List versus an Infested List (a determination must made whether there is an established reproducing population). It also presents criteria for delisting a lake if zebra mussels are no longer detected. A review team consisting of the Exotic Species Statewide Coordinator, Ron Martin, and region representatives make the final determination for listing or de-listing a waterbody.

Infested List:

DNR lists a waterbody as infested for zebra mussels when we have data indicating that there is an established reproducing population. That would mean that we detect evidence of in-lake reproduction.

Watch List:

When veligers, post-veligers or adults are detected in a lake sample, the regional biologist and statewide coordinator (Ron Martin) are contacted. The biologist is requested to conduct a lake survey at their earliest opportunity. In general, the survey would include examining shores, piers and other available substrate near where the plankton tow with the veliger was collected. Additional plankton

tows and scuba diving or underwater video surveys may be warranted upon the discretion of the biologist. If the veligers, post-veligers and/ or adult zebra mussels found are all from the same year class, then the waterbody is placed on the "Watch" list to be targeted for additional follow-up work by DNR staff. Waterbodies on the Watch list are monitored for zebra mussels and usually include increased public information and education efforts.

Table 2 provides the zebra mussel listing recommendation criteria. A water body is recommended to be placed on the "Watch" or "Infested" list based on meeting one or more of the criteria. Ultimately, the Regional resource managers, in consultation with the aquatic invasive species program coordinator, determine the appropriate listing for a waterbody.



Table 2. Zebra mussel listing recommendation criteria.

Watch List	Infested List
Adults all the same size, or post-veligers (from substrate analysis) or veligers all from the same year.	Adults zebra mussels of different sizes.
Low numbers of veligers and a substrate evaluation was negative.	Adult zebra mussels found in more than one location of the waterbody. Veligers need not be found.
	Veligers or post-veligers (from substrate analysis) from consecutive years.
	Veligers and adult zebra mussels present.

Footnote: Although the listing criteria reflect monitoring for both veligers (larvae) and adults, it should be noted that only lakes are monitored for zebra mussel veligers, not streams or rivers.

Delisting Criteria:

Unfortunately, once zebra mussels become established in a waterbody it is unlikely that they will be eradicated. Nonetheless, if a waterbody is listed as infested for zebra mussels, but subsequent information indicate that they are no longer present, we can use the following criteria to delist a waterbody as infested.

<u>All</u> the following need to occur for <u>at least two</u> <u>years</u> to delist a waterbody:

- Based on additional monitoring, no veligers are observed in any of the samples collected from May through September following the standard monitoring protocol.
- Substrate samplers are deployed at three or more locations in the lake from May through September, concurrent with the veliger collections above, and all are negative for zebra mussels.
- A lake survey is conducted, and survey results of suitable habitat show no adult zebra mussels are present. (Obviously,

the survey(s) should include the location where zebra mussels had been detected in the past).

- A scuba and/or underwater camera survey is conducted in the area(s) where zebra mussels had been detected in the past (optional).
- *When these conditions are met the waterbody may be delisted if regional resource managers recommend delisting and the statewide coordinator concurs.

Delisted waterbodies would be moved to the Watch list and continue to be monitored for zebra mussels. Waterbodies on the Watch List remain on that list unless they are moved to the Infested List or if subsequent long-term sampling results indicate that no veligers or adults are present. Hence, no delisting criteria are recommended for Watch List waterbodies.
