## 1200 MAJOR WORK PROGRAM ELEMENT Water Quality Management Planning Program Administration and Coordination <u>3rd Quarter Progress Report</u>

## WQM Program Progress Report Overview

- The ECWRPC has not yet received a contract amendment from the WDNR for the work completed July 1, 2022 through December 31, 2022.
- The ECWRPC will need a Purchase Order Number from the WDNR in order to submit an invoice for the 3<sup>rd</sup> and 4<sup>th</sup> Quarters.
- <u>Expenditures for Quarter 3 totaled \$37,701.78</u> The budget table from ECWRPC's accounting system is enclosed.
- Updating the ECWRPC's Policies and Procedures document for the WQM Program was included as a deliverable in the 2022 Work Program. ECWRPC staff began research to update the policies and procedures in Quarters 2 and 3. However, during a WQM Program Meeting with ECWRPC staff and WDNR staff on September 13<sup>th</sup>, WDNR staff mentioned that they will be more available to work with the ECWRPC staff on new policies and procedures in the year 2023. Therefore, this deliverable will be included in the Work Program for 2023. Work on the Fox Cities 2040 SSA Plan will continue in 2022. The Policies and Procedures will be updated separately, as opposed to the original plan for a congruent update to both documents.

- Staff researched documents and all communication related to the Oshkosh SSA Plan Amendment (Track 173) to prepare timeline and submit additional information to the WDNR, as requested, regarding the Commission's communication with all interested parties during the SSA Amendment review
- Staff evaluated the Town of Algoma Sanitary District's and the City of Oshkosh's cost-effectiveness analyses and prepared a staff report and final analysis of the findings with a recommendation for the Community Facilities Committee (CFC) in August, and the WDNR
- Staff attended check-in meeting with WQM Program manager in Brown County to coordinate on SSA planning program management activities
- Staff held internal check-in meetings with ECWRPC leadership to discuss WQM Program updates and status of various projects and conformance reviews
