PUBLIC ACCESS

Petenwell and Castle Rock Lakes are the second and fifth largest lakes in Wisconsin with many public landings. Adams County has several other lakes with over 100 surface acres: Arrowhead, Upper Camelot, Lower Camelot, Sherwood, Big Roche a Cri, Friendship, Jordan and Mason. There are at least six public beaches. There are county parks on at least ten of the lakes. There are at least four public fishing piers, all installed in the last few years with assistance from the Adams County Land & Water Conservation Department. All of the lakes have at least one platted public access. There are private resorts on at least six of the lakes.

Maps of these areas have been previously submitted to the WDNR in other grant applications and are on file with the WDNR.

DESCRIPTION OF PROJECT AREA

Adams County lies in south central Wisconsin with a full-time population of about 20,000. Currently, about 45% of the county is forested, with about 25% in various agricultures, 2-5% in residences (depending on watershed), and the balance in wetlands and grasslands. Primary land uses now include forestry, agriculture (often with center pivot irrigation), cranberry production and recreation. Tourism

has increased in the last 20 years. There are 17 towns, City of Adams and Village of Friendship.

Adams County watersheds are Fourteenmile Creek (184.15 sq mi); Big Roche a Cri Creek (177 sq mi); Little Roche a Cri Creek (196.2 sq mi); Duck Creek (171.73 sq mi); and Neenah Creek (182 sq mi). All but Neenah Creek Watershed feed into the Wisconsin River; Neenah Creek Watershed feeds eventually into the Fox River. Seventy-two miles of streams in Adams County have been designated "Outstanding Water Resource" or "Exceptional Water Resource." The western part of Adams County is bordered by the Wisconsin River. Peppermill Creek (WBC 178400); Petenwell flowage (WBC 1377100); Castle Rock flowage (WBC 1345700); Mason Lake (WBC 175700); unnamed tributary (now named Cody Creek) to Mason Lake (WBC 175800) and Big Spring Creek have been declared "impaired" under 303(d) provisions by the Wisconsin DNR.

Adams County has 22 named lakes, all but one of which have lake districts and/or associations who are seeking ways to improve their lake. The one named lake without a district and/or association is in the process of forming an association due to the discovery of a large population of hybrid milfoil in their lake in 2011. The western edge of the county is formed by the Wisconsin River, as well as Petenwell and Castle Rock Lakes.

Based on the most recent aquatic plant surveys, at least ten of the lakes with public access in Adams County have FQI scores higher than the average for the State of Wisconsin and for the North Central Hardwood Forest Region. Fourteen of the lakes have designated Critical Habitat areas. At least two lakes contained threatened aquatic species. Thus, several of the lakes in Adams County have high biodiversity that needs to be protected.

Several waters in Adams County are on the **303(d) list: Mason Lake; Castle Rock Lake; Petenwell Lake; and several streams.** Petenwell and Castle Rock Lakes are considered "superspreaders" by the Wisconsin Department of Natural Resources.

Adams County Land & Water Conservation Department works closely with all these areas, including a stream monitoring program that including identifying aquatic invasives in the local streams. One of the recently discovered invasive in Mason Lake was *Najas minor* (Brittle Nymph), which is on the NR 40 Prohibited List. Adams County LWCD and the WDNR are working with the Mason Lake District to regularly monitor this population and, if necessary, to develop a management plan for it.

Almost all the lakes with public boat launches have a high public use and are a major source for AIS spread. All the named lakes with public access have one or more identified AIS. The Wisconsin River watershed drains about 21% of Wisconsin. It has long been recognized that excessive nutrient loading has created several problems, including regular and extensive algae blooms on Petenwell and Castle Rock Lakes. Since 2010, Adams County LWCD has coordinated and participated in the Wisconsin River TMDL project. This includes training and coordinating up to 19 volunteers to perform bi-weekly on-lake monitoring, collating and entering their data into SWIMS, as well as taking algae samples to check for potentially toxic blue-green algae and entering the data into the Federal Phytoplankton database in a project with NOAA and the CDC. It is anticipated that the packets will be distributed to waterfront owners along Petenwell and Castle Rock Lakes in Adams County, as well as river waterfront owners in Adams County. Hopefully, this will assist in owners taking steps to reduce input into these lakes and the river.

DESCRIPTION OF PROBLEM TO BE ADDRESSED

Inland lakes with public access in Adams County have nearly 83 miles of shore. There are more than 100 miles of trout streams in Adams County, and several hundred miles of other streams. The Wisconsin River, including Petenwell and Castle Rock Lakes, runs along the west side of the county for over 60 miles. These figures show that there are miles of waterfront property in Adams County.

Adams County was one of the first state counties to amend its shoreland and wetland zoning ordinance after the amendment of NR 115. The ordinance requires every waterfront property in Adams County to have installed a shoreland buffer by July 1, 2015, or an approved mitigation substitute. The planting requirements include planting of native species.

In its work with waterfront property owners, Adams County Land & Water Conservation Department has found, through various public meetings and lake organization meetings, that many waterfront property owners are not only not clear on what they should do to comply with the county ordinance, but also have many questions about what they can do to improve and maintain their property without harming ground and surface water quality. In addition, waterfront property often changes hands, leaving new owners without even the most basic information about their property.

Also, Adams County Land & Water Conservation Department continues to receive requests from several from lake organizations for **educational and technical assistance** about various lake issues. Adams County LWCD has worked with the lake organizations in the county to develop lake management plans. At this time, 20 of the 22 lakes in Adams County with public access have lake management plans approved by the WDNR. Each of the lake management plans includes an education component. At the request of the various lake organizations, the Adams County LWCD developed a packet of material on various lake topics that could be distributed. After examining the packet, several lake organizations requested packets for distribution to **all** their waterfront property owners because they felt the packet provided information that waterfront property owners should have.

Adams County LWCD previously applied for a grant to prepare 2500 waterfront packets and 25 CDs of packet contents for distribution to various waterfront property owners and members of the public. Between the time the grant application was made and approval of the grant, printing and copying costs increased dramatically in the county. For example, the cost of a color print went from \$0.02 per copy to \$0.06 per copy. Also, brochures included in the packets that were previously obtained free from UW-Extension Lakes and Wisconsin Department of Natural Resources are now only available at a cost.

The purpose of this grant is to complete the scope of the original project and finish supplying the packets ordered by the lakes in Adams County. After finishing stage one of this project, 1200 packets have been distributed to local lake organizations, as well as 14 copies of the CD containing packet contents. There are still orders for another 1200 packets. The remaining 100 packets and remaining CDs will be distributed to local realtors and libraries.

PROJECT GOALS AND OBJECTIVES

GOAL: To complete providing the educational packet to the Adams County Lake organizations and waterfront property owners about water quality, shoreland/wetland zoning requirements, shoreland restoration/preservation, aquatic invasive species, stormwater runoff, rain gardens, and other lake-related issues.

Objective: To complete the balance of packet orders and have sufficient packets so Adams County LWCD will have packets to distribute to waterfront property owners, local realtors, and libraries. Each lake organization and the libraries will also be given a CD that contains the packet contents, so that they can reproduce the packet for in-coming waterfront property owners as well.

DESCRIPTION OF METHODS AND ACTIVITIES

Shore Packet Table of Contents: The packet distributed to the lake organizations for review includes the following contents (a copy of the packet is attached and incorporated by reference:

Some of the items listed can be obtained pre-printed for a cost and assembled into the packet. However, more than one-half of the items listed will have to be printed by the applicant's staff. The Adams County LWCD does not have the funds to cover the cost of reproducing so many items without this grant. Packets will be assembled by staff of the Adams County Land & Water Conservation Department to ready them for distribution. CDs have been prepared by Adams County LWCD staff.

PROJECT DELIVERABLES

1. 1300 waterfront property owner packets.

2. Distribution of packets and CDs to lake organizations, local libraries, local realtors, and other public forums.

3. Report to the WDNR on activities, progress and completion of this grant.

DESCRIPTION OF EXISTING & PROPOSED PARTNERSHIPS

Adams County Land and Water Conservation Department works with the following organizations and agencies on lake issues: Wisconsin Department of Natural Resources; U.S. Army Corps of Engineers; USDA Natural Resource Conservation Service; USDA Farm Service Agency; U.S. Fish and Wildlife

Service; Golden Sands RC&D; UW-Extension; Adams County Planning & Zoning; Adams County Board; Boards of the towns and villages in Adams County; Adams County Parks Department; Adams County Highway Department; Adams County Corporation Counsel; the Water and Environmental Analysis Lab UW-Stevens Point; individual Lake Association and Districts within Adams County; Wisconsin Lakes, and Adams County-wide Lake Alliance Group.

ROLE OF PROJECT IN PLANNING AND/OR MANAGEMENT OF LAKES

Each packet contains various pieces of information about aquatic invasives in Adams County and will add to the water quality monitoring, AIS monitoring, and Clean Boats, Clean Waters programs already on-going in Adams County. Twenty-two of the lakes have had citizens trained by the Adams County LWCD in the "Clean Boats, Clean Waters" program as well. The larger lakes have regular boat inspection monitoring, while the smaller lake participate on a less regular schedule, depending on the boat traffic to their lake. These programs provide a method of early detection so control and eradication may be possible. At least four lakes have boat washing stations near their boat launches and three other lakes have asked the Adams County LWCD for assistance in developing such stations at their lakes

As noted above, production and distribution of such packets are included in all of the lake management plans in Adams County that have already been approved by the Wisconsin Department of Natural Resources. It is anticipated that receipt and review of the packet contents will assist the Adams County Land & Water Conservation Department and various lake and watershed organizations in educating their constituents and will also create more knowledgeable waterfront property owners that can assist in improving/maintaining waterfront properties and the adjacent waters.

TIMETABLE FOR IMPLEMENTATION:

Printing of Packet Materials: October and November 2013.

Construction of Packets: November and December 2013

Final Distribution of Packets and CDS: December 2013-March 2014.


PLANS FOR SHARING PROJECT RESULTS

Packets produced will be distributed initially to lake organizations that have "ordered" a particular number of packets. Several remaining packets will be distributed upon request to other lake organizations or waterfront subdivisions. A copy will be placed in the Adams County and Town of Rome public libraries. Some packets will be delivered to local realtors for distribution. Each lake has also asked for a few packets to give to new waterfront property owners as they arrive at the particular lake. Lake organizations will also be provided with a CD containing the packet materials, so that they can reproduce packets in the future as they need.

These packets will inform the public receiving them about several lake management issues and include information on ways members of the public can assist in lake management. These will be also presented to the various lake organizations in the county at lake organization meetings and to the Adams County Board.

Final packets will be **delivered to lake organizations** ordering them, but also to local libraries and local realtors. Information about their availability will also be posted on the department website and presented in the local newspapers through press releases and articles about the packet contents.

Since these packets will be distributed county-wide and contain information about lake issues, including water quality, shoreland/wetland zoning requirements, shoreland restoration/preservation, aquatic invasive species, stormwater runoff, rain gardens, and other lake-related issues, it is anticipated that they will **provide information on lake ecosystems that will help the lakes in the county as a whole.**
