Dear Mr. Peontke:

On July 1, 2021, the Department of Natural Resources (DNR) sent you a letter requesting a site update for the above-referenced case, located at 1870 State Highway 47 in Lac du Flambeau, Wisconsin (Property). To date, the DNR has did not received an adequate response to that request for information.

In accordance with Wisconsin Administrative (Wis. Admin.) Code § NR 728.11(2)(b), you are hereby notified that the DNR intends to record an affidavit at the Vilas County Register of Deeds office giving notice of contamination at the Property at 1870 State Highway 47 **unless you respond to this second letter in writing, within 30 days of receiving this letter (date of delivery confirmation), informing the DNR of your plans to finish the necessary environmental response actions at this site.** As part of this response, please include the name and contact information of the environmental consultant you have hired to conduct the response actions.

The DNR has also notified the mortgage lender for the Property identified below. You should provide a copy of this notice to any other parties with interest in the Property not identified by the DNR.

In accordance with Wis. Admin. Code § NR 728.11(2)(c), if an acceptable response is not received within the time period set forth in this letter, the DNR may, as soon as practicable but in no case less than 15 days after the 30-day deadline, record a Notice of Contamination affidavit at the office of the register of deeds for the county in which the Property is located. A copy of the Notice of Contamination affidavit to be filed is enclosed with this letter.

I, Christopher A Saari, being first duly sworn, state that:

1. I am a Remediation and Redevelopment Program Supervisor, employed by the Wisconsin Department of Natural Resources (hereinafter "the Department") at its Northern Region.
2. I have personal knowledge of the facts herein set forth and believe the same to be true.
3. The Department has determined that petroleum-related compounds were discharged to the soil at the Ken Francois Property, now known as the James Peontke property ("the Property"), which is located at 1870 State Highway 47, in the Town of Lac du Flambeau, Vilas County, and which has the above legal description.
4. The Department has determined that soil contamination has been identified on the Property which has not been adequately defined or remediated.
5. On December 11, 2020, the Department sent a Responsible Party (RP) letter to Mr. James Peontke advising him of the statutory requirement to restore the environment at that location. That letter requested Mr. Peontke hire a licensed environmental consultant within thirty (30) days and submit a site investigation work plan within sixty (60) days. No response to that letter has been received by the Department.
6. On March 3, 2021, the Department sent a request for status update letter, by certified mail, to Mr. Peontke and informed him of his responsibility to investigate and clean up the site.
7. Per Wis. Admin. Code § NR 728.11(2)(a), on July 1, 2021, the Department sent a letter, by certified mail, to Mr. Peontke advising that a notice of contamination would be recorded if satisfactory action to address the environmental contamination did not commence.
8. Per Wis. Admin. Code § NR 728.11(2)(b), on October 22, 2021, the Department sent a letter, by certified mail, to Mr. Peontke and New Penn Financial LLC, dba Shell Point Mortgage Servicing, advising that the Department has made the decision to record a notice of contamination for the above-described property at the county Register of Deeds office. The 30-day response time set out in the letter has expired. Additionally, per Wis. Admin. Code § NR 728.11(2)(c), the 15-day waiting period since that deadline, required by Wis. Admin. Code ch. NR 728, has passed without an acceptable response.

9. Because the Department believes that petroleum-related contaminants found in the soil on the Property with the above legal description, will continue to discharge into the environment, subsequent purchasers of the Property could be held responsible for investigation and cleanup costs under Wis. Stat. § 292.11(3).
