Good morning Linda,

Per our discussion I reviewed our letter report from July 2020 that provided the results of post-construction sub-slab testing. The report indicated the vapor system risers were “temporarily sealed” in December 2019 prior to sample collection in January 2020. To clarify, the risers were sealed above roof level with vapor barrier tape and have remain sealed in this manner as sub-slab vapor results collected to date have not indicated appreciable risk. If additional sub-slab results are consistent we anticipate unsealing the risers and allowing the system to operate passively but not as a continuing obligation.

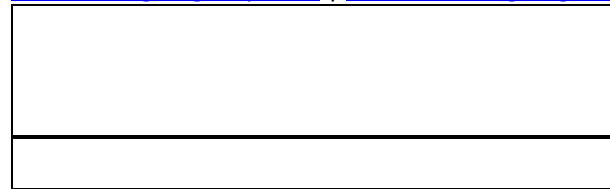
