I reviewed the NR 700 SA Progress Report submitted for the Donaldson's case and need to communicate that the progress report, which uploads directly to BRRTS on the Web, does not reflect the current status of this site. While a request for closure was initially received March 6, 2017, it was not tracked as administratively complete until May 8, 2017 and the case was not approved for closure after review by the NER Closure Committee.
