Dear Messers. Donaldson:

On January 7, 2013, the Department of Natural Resources (DNR) issued Donaldson's One Hour Cleaners, Inc. and H & J Investments, LLC letters of responsibility for contamination reported at the property listed above. A letter was issued by the DNR on June 20, 2017 denying the request for closure and detailing additional actions needed to comply with requirements under s. 292.11, Wis. Stats. and the NR 700 Rule Series. This letter requested the nine 55-gallon drums of investigative waste stored outdoors on-site be properly characterized and disposed by August 19, 2017. In addition, the letter requested a written schedule of plans to address the additional investigation and cleanup actions needed at the site be submitted by August 19, 2017. The DNR received a brief email on August 29, 2017 from SCS Engineers stating that a scope of work is being developed along with coordination for disposal of the drums; however, no time frame or additional detail was provided. As of the date of this letter, the DNR has not received an adequate response to the June 20, 2017 closure denial letter.

Within 14 days, by <u>September 13, 2017</u>, a written status update that includes the information requested in the June 20, 2017 letter should be submitted to the DNR. Please be aware that the DNR is responsible to assure that releases to the environment are adequately addressed in a timely manner. Donaldson's One Hour Cleaners, Inc. and H & J Investments, LLC are currently out of compliance and will remain out of compliance until reporting requirements are met. Your responsibilities outlined in state statutes were communicated in letters dated January 7, 2013. The DNR may involve an Environmental Enforcement Specialist to assist in moving this site forward.
