Dear Mr. Czarneski:

It has come to the Department of Natural Resources' (DNR) attention that plumbing work (e.g. installation of a grease trap) is intended to be performed at the address referenced above. The DNR recommends that no modifications be made to the building without first performing a vapor intrusion investigation to assess potential contamination beneath the slab of the building.

Based on the data and historical use of the property as a dry cleaner, it is highly anticipated that environmental contamination is present beneath the building at levels that pose a risk for migration of the chemical vapors into the indoor air. It is anticipated that a vapor mitigation system and possibly other actions will be needed to protect the indoor air from the environmental contamination. Modifications to the building that create additional pathways to the subsurface, such as installation of a grease trap, will likely enhance migration of contamination into indoor air. The DNR understands that this grease trap could also be installed above ground, which requires no cutting of the floor; this option is preferable for protection of indoor air.

Included with this letter are two fact sheets on trichloroethylene (TCE) and vapor intrusion (VI). Please review the attached fact sheets, and do not hesitate to contact me with any questions or concerns you may have. My direct line is 920-662-5424 or Josie.Schultz@Wisconsin.gov.

Thank you for your attention to this matter. I will be contacting you in the near future to follow-up on investigation of the historical release, including performing a vapor intrusion investigation.
