Debby,

Based on the original cost request, all of the direct push borings at the site were going to be completed as temporary groundwater monitoring wells (NR 141.29). The request included the Commodity Temporary Monitoring Well Installation DP75 and Consultant Temporary Well Installation DP-25. When temporary wells are installed, their abandonment is covered under Task 1 GS30 Temp Well Abandonment. The February 11, 2019 approval provided temp well abandonment costs for each of the 15 temp wells anticipated. If the temp wells were not installed, then the DP-75 and DP-25 should not be claimed and I can go ahead and approve the soil boring abandonment. Let me know how many temp wells were installed and then I can adjust the cost approval for the borings that were only completed as boreholes.
