Dear Mr. Butz:

On February 6, 2014, the Department of Natural Resource's South Central Regional Closure Committee reviewed your request for closure of the Reedsburg Cleaners case. The Committee reviews environmental remediation cases for compliance with state rules and statutes to maintain consistency in the closure of these cases. After careful review of your closure request, the Committee determined that additional work is needed to meet the closure criteria.

Vapor Investigation

Additional vapor sampling is needed to assure no one is exposed to tetrachloroethene (PCE) vapors. Particularly, the concern is for migration of vapors toward residential properties to the north and west of the site. We suggest collecting one sub-slab vapor sample at the northwest corner of the on-site building and one soil gas sample near the PCE source area.

Groundwater Monitoring

Another two rounds of groundwater monitoring are needed. The most recent data show a good reduction in PCE and breakdown products, but the trend is not clearly established. Groundwater contaminant concentrations sometimes rebound following remedial actions. The additional monitoring will clarify the longer-term contaminant trends in groundwater.

Remedial Action

Additional remedial action may be needed. Depending on the results of the vapor sampling and groundwater monitoring, you may need to take additional actions including vapor mitigation and/or additional remedial injections of whey.

Please send me a schedule and cost estimate to meet these requirements by May 1, 2014.

We sincerely appreciate all of the effort you have already taken to restore the site.
