The purpose of this e-mail is to follow-up on your recent communications with Joel Smullen from Marquette University (Marquette) regarding your February 11, 2022 letter requesting PFAS groundwater sampling at the Former Taxman/One Hour Valet site in Milwaukee (BRRTS 02-41-152248). Based on our review of the request and discussions with Marquette, Ramboll is proposing to perform the following additional PFAS sampling as part of the routine semi-annual groundwater sampling event scheduled for April 2022.

- Collect a groundwater sample from piezometer well PZ-1R and submit to Pace Analytical for laboratory analysis of PFAS (WI 33 compound). One duplicate sample, field blank, and trip blank will also be included for quality assurance and quality control (QA/QC) purposes.
- Collect a groundwater sample from upgradient monitoring well MW-2 for possible PFAS analysis. The laboratory will be instructed to extract and hold the MW-2 sample pending receipt and review of the PZ-1R and QA/QC sample results. It is Ramboll's opinion that even though MW-2 and PZ-1R are screened at different depth intervals, results from this upgradient monitoring well location can still provide useful information regarding PFAS concentrations near the upgradient portion of the property that may be influencing the results received for the PZ-1R sample.
- Provide a WAC NR 716.14 data transmittal with the PFAS sampling results to the WDNR within 10-business days of receipt of the final laboratory analytical report.
- Formally present the PFAS groundwater sampling results in the routine semi-annual progress report that will be prepared following the April 2022 sampling event.
