The Department of Natural Resources is reviewing environmental contamination sites that have been inactive for several months.

In our review of the above referenced property, the Department found the most recent correspondence to be a letter from you, dated May 20, 2011, regarding the identification of Mr. Ron Anderson at METCO as your environmental consultant.

The file also contained e-mail memos between Ron Anderson and the Department on May 23, 2011 in which he requested and was provided with the Notification and letters to the Responsible Party. It was our understanding that Ron Anderson would be preparing and submitting a work plan and schedule for the Site Investigation. Please have your consultant provide the Department with a written update regarding the status of this project.

The Department was notified on June 17, 1997 that unleaded gasoline leaked from an underground storage tank removed from the site on June 16, 1997, causing soil contamination and potential groundwater contamination. It appears that no additional investigation or remediation has been performed at the site since 1997.
