Pursuant to your July 13, 2000 letter conditionally approving the May 23, 2000 *Site Investigation Work Plan* and May 30, 2000 *Site Investigation Work Plan Addendum*, the purpose of this letter is to request an extension to the site investigation completion deadline (90 days from receipt of the July 13, 2000 letter) for the above referenced site.
