
ACCESS PERMISSION FORM

I hereby give my permission to the Wisconsin Department of Natural Resources and its employees, duly authorized representatives, agents and contractors, to enter upon and have access at reasonable times to the property located at 2626 Memorial Drive, Two Rivers, WI 54241 in Manitowoc County (County Tax Parcel # 053-211-101-000.01 as shown on the attached map) that is owned by Mr. David Herrmann for the following purposes, so that the Department of Natural Resources can replace the pavement (cap) that was previously removed:

After October 31, 2023, if the property owner wishes to withdraw permission for continued access, the property owner shall notify the Department of Natural Resources of that fact.
