The Wisconsin Department of Natural Resources (Department) will be conducting a Phase I Environmental Site Assessment on the Charles Matthews Estate property (the "Property"). The Property is located within the NE ¼, NE ¼, Sec. 17, T.13N R.11E, Town of Scott, Columbia County and identified as parcel #11036 347.02 (see attached map). The Department and its employees, representatives, agents and contractors may be accessing the Property via an easement associated with the Property that is on the eastern side of parcel #11036 347.03 owned by you and identified with the name "David Maginnis" on the attachment. The site assessment activities include the installation of groundwater monitoring wells and collection of soil and groundwater samples. The Department is notifying you that the access may impact area you have put into cultivation which is part of the Matthews Estate Property. Work is anticipated to be completed by June 1, 2020.
