You should also measure free product thickness in the well prior to ground water sampling. These items will need a bid deferral.

The lithology varies from gravel to silty clay, silty sand to sandy silt. Do you have any cross-sections drawn at this time that you could refer me to?

Is there a remedial action that you would recommend and that would be effective in this environment?
