Hi Lynn,

I discussed Speaker with Steve. I would like you to resubmit the request. I would like to see the following additions to the request:

- A second well, MW-8, to be installed west of the proposed MW-7 (see attached map). Please check overhead for locating the well locations.
- Are the homes on private water or municipal? If PWs, I want to see Speaker, Lutzen, and the home in between sampled for gasoline constituents. If on municipal water this is not needed.
- In addition to the aerial photo research on Speaker, I would like to know the property boundaries of the former Town of Ida property on the south side of Hwy 18, the location of ASTs or USTs associated with that property and if, when, how those tanks were closed. If this is not on Sanborns or elsewhere in your files, you might need the aerial photos for this property as well.

I also am curious as to why the water table map, in the February 18 status update, did not use MW-2 to draw contours (see attached for a possibility).

You should start to think about the next steps (remedial measure) at Speaker. Looking at the nature of the soils (silty, clayey sandy materials), an excavation should be considered in the vicinity of at least GP-7, GP-2, and GP-10.
