I have reviewed your bid deferral and variance request for Speaker Property.

PECFA will not approve the Change Order request (task 36) but will approve a Regulatory Correspondence (task 7). PECFA will not approve the variance for GEC client and contractor coordination.

In 2016 we had a similar situation at Speaker where dirt was needed to repair ruts from drilling. This property is one where you need to be aware of time of year and weather conditions as the ground gets soft, mushy, and difficult to work on without causing damage. We discussed this in 2016.
