Dear Mr. & Ms. Skaife:

On March 8, 2005, under direction from the Wisconsin Department of Natural Resources (DNR), an Affidavit (which will hereafter be referred to as a Notice of Contamination) was filed as Document Number 676127, of Volume 1054, Page 805, at the Register of Deeds in Grant County with the intent to notify the public of contamination existing at 6832 USH 18, Town of Mount Ida, WI (Property). The DNR, in accordance with the Wis. Admin. Code chs. NR 700-799 and Wis. Stat. § 292.11(3), determined all administrative and statutory obligations for this release of contamination had not been met and the Notice of Contamination was filed. The Notice of Contamination recorded under Wis. Admin. Code § NR 728.11, was to notify the public of the existence and potential liability of petroleum contamination associated with ownership of the Property.

Since that time, remedial actions have been taken to address the source of contamination and impacts to the environment. On October 20, 2020, pursuant to Wis. Admin. Code ch. NR 726, the contamination case on your Property was closed with continuing obligations as some contamination remains in soil and groundwater. In accordance with Wis. Admin. Code § NR 728.11(3), this letter is to advise you that the DNR has made the decision to record a second Affidavit (hereafter referred to as a Deed Notice) that supersedes the original Notice of Contamination for the Property. Per Wis. Admin. Code § NR 728.11(3), this Deed Notice is being recorded for the purpose of notifying prospective purchasers and other interested persons that the previously recorded Notice of Contamination, filed on March 8, 2005, as Document Number 676127, of Volume 1054, Page 805, has been satisfied and is no longer applicable to the Property.

Attached are drafts of the documents the DNR is in the process of filing. The DNR will provide you with a final copy of the filed Deed Notice once it has been recorded and returned from the Register of Deeds office. EXHIBIT A

Written Determination by the Wisconsin Department of Natural Resources

- 1. A Notice of Contamination was recorded at the Register of Deeds in Grant County, Wisconsin, on March 8, 2005, as Document Number 676127, of Volume 1054, Page 805. It applies to the property located at 6832 USH 18, Town of Mount Ida, Wisconsin (Property) which is owned by Michael and Debra Skaife.
- 2. The Notice of Contamination recorded under Wis. Admin. Code § NR 728.11, was to notify the public of the existence and potential liability of contamination associated with the Property. The Wisconsin Department of Natural Resources (DNR), in accordance with the Wis. Admin. Code ch. NR 700 rule series and Wis. Stat. § 292.11(3), determined all administrative and statutory obligations for this release of contamination had not been met. Because the DNR believed contamination would continue to release to the environment, it was necessary to notify the public and any subsequent owner, of the liability associated with the contamination on the Property.
- 3. The Property was formerly used as a gas station and tavern. Contamination was reported to have leaked from two 500-gallon Underground Storage Tanks (USTs) which were used to store unleaded petroleum. The release of petroleum products from the USTs to the environment was reported to the DNR on December 12, 1997.
- 4. On November 18-19, 2019, a remedial excavation took place removing approximately 658 tons of petroleum contaminated material from the Property. During the remedial excavation, 30-gallons of Oil Spill Easter II was diluted in clean water along with 2,010 pounds of calcium peroxide and 7.5 gallons of aerobic bacteria, which was then applied to the impacted soils in order to increase bioremediation. On June 11, 2020, the site was reviewed for closure and on October 20, 2020, the site was granted closure with continuing obligations.
- 5. Thus, at this time, with the information available, the release of contamination at the Property has been determined to meet all administrative and statutory obligations in accordance with the Wis. Admin. Code chs. NR 700-799 and Wis. Stat. § 292.11(3). Please refer to the Continuing Obligations packet found on BRRTS on the Web, for the list of continuing obligations which currently exist at the Property located at, 6832 USH 18, Town of Mount Ida, Wisconsin.
- 6. Therefore, the environmental contamination previously identified on this Property has been adequately addressed and the previously filed Notice of Contamination as Document Number 676127, of Volume 1054, Page 805, has been satisfied.
