On 03/24/2003, the Hunn Family Trust was notified by the Wisconsin Department of Natural Resources (DNR) of your responsibility to investigate and, as needed, clean up contamination located at the above-referenced property. As the responsible party of this property you have certain legal responsibilities, as outlined in Section 292.11(3), Wisconsin Stats., also known as the hazardous substances spills law. Section 292.11(3) states:

RESPONSIBILITY. A person who possesses or controls a hazardous substance which is discharged or
who causes the discharge of a hazardous substance shall take the actions necessary to restore the
environment to the extent practicable and minimize the harmful effects from the discharge to the air,
lands or waters of the State.

Our files indicate that we have not received any written correspondence or reporting for the case since the DNR identified the Hunn Family Trust as the responsible party in 2003. In order to get this case back on track toward remediation of the existing contamination and ultimately, DNR case closure, please submit or have your consultant submit any existing documentation on the status of this case, within thirty days. A lack of response to this letter may result in the initiation of formal enforcement.

DERF Project: Our records also indicate that this property is in the Dry Cleaner Environmental Response Fund (DERF) cleanup process. To retain eligibility for reimbursement of investigation and cleanup expenses, you will need to follow the requirements of ch. NR 169, Wis. Adm. Code.
