Jason,

Ron asked me to provide you with the number of potable wells to be sampled and the number of vapor sampling ports for you to determine the costs you need to submit for approval under PECFA. If Arlene's Inn is 5000 feet or greater, 3 sample ports need to be completed; if it is less than 5000 square, it would be a maximum of 2 ports (depending on the area).

With regards to the number of potable wells, it will be a maximum of 6 wells. It is likely that it might be less, as many houses in Willard are not inhabited. I will provide you a map and address of the homes/businesses when you are ready to sample.
