If you do not respond to this letter the Department will issue a notice of violation (NOV). You will be requested to attend an enforcement conference to discuss the status of the above referenced case.

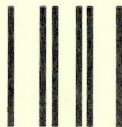

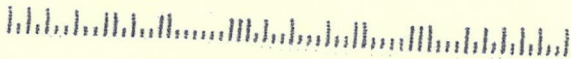
