Ron,

Attached is the most recent data table I have in the file and site maps. More data is in the file but unfortunately we have never received updated tables only lab sheets. This should give you a good idea of the general site conditions though.

To get an idea if closure may be an option at some point in the somewhat near future, I suggest groundwater samples be collected and analyzed for full VOCs at monitoring wells MW9, MW10, PZ2, OOC-MW1 and OOC-MW2. It would also be great to get a sample from the apparent release area underneath the building but it is not clear to me if any monitoring points exist in that area.
