Yes, Rebecca provided the forms shortly after you contacted her (I received them in July 2018). PECFA is now requiring an updated W-9 so I will need her to sign one before we can do any work. But I think she will be OK with that.

I have not gotten to this Closure request. As you know, we (consultants) are swamped trying to finish PECFA work before it expires in a few months. I should finish my field work for the year in the next couple weeks and then plan to work on Closure requests over the winter including Grace's Store site.

One of the problems I foresee with the Grace's Store site is I haven't been to the site in 4 (more?) years and do not know the current site conditions. Additionally, the Closure request asks for a map of private wells within 1200 feet of the site. This will require a Potable Well Reconnaissance. Also, as you know, the DNR GIS Registry process has become very

"picky" over the past few years. The site map will likely have to be re-drafted. Finally, I need to see if all of the monitoring wells are still there or if we have some 'lost' wells.

Will DNR require a PE signature on the Closure Form? If so, I will need to have the PE visit the site and review the file.

I will send a Cost Request for this additional work in a few months when I get to this project.
