



On April 11, 2018, the Wisconsin Department of Natural Resources (Department) received a scope of work (SOW) and cost estimate utilizing the chapter NR 747, Wisconsin Administrative Code, Usual and Customary Cost Schedule (Cost Schedule) for the site referenced above.

The Department has determined that the submitted SOW is reasonable and **approves** the additional costs. This site will be deferred from the public bidding process at this time. The Department will contact you if this site will be bid in the future.

This approval is for the installation of (7) new monitoring wells, and (2) rounds of groundwater sampling (PVOC + Naphthalene) from the following wells: MW-1,2,3,5,6,7,8A, 8B,9A,9B,10A, 10B, seven new wells, private wells (14789 STH 73-Keeper's new private well (VOCs), Jim's Bar, 8910 Elm, 8907 Birch, 8897 Birch, 8891 Bridge (Conv Store), 8890 Bridge, 14778 River, and 8887 Bridge. Nine (9) soil borings with sampling (PVOC + Naphthalene), installation of (6) soil vapor extraction vents, waste disposal and a letter report upon completion. A copy of the Department worksheet for the Cost Schedule tasks is enclosed for your reference.
