Carrie.

This note follows our phone conversation yesterday morning in which we discussed the new well at the Country Store in Jump River. Please recall the new well was hooked up on Tuesday (21st). The Store contacted me Thursday afternoon and said the water pressure (flow rate) was very low. I contacted the well driller and the plumber who returned to check the system Friday morning. They determined the sediment filters we installed before the carbon filter unit had clogged due to the new well. This issue will decrease as the well is pumped. The plumber replaced the sediment filters which fixed the problem.

I will receive an invoice from the plumber for the sediment filters and labor. I will let you know how much that is...I am guessing it will be about \$250 (?).


