Interesting, I think there's another mass of soil above regulatory standards on the guy's property unfortunately - from a source that is unknown, but it is defined. The attachment email was per the Closure Committee Review discussion. I wish it (all contaminated soil) was in the ROW, that would make things easier and a NAR would be appropriate, but it's not that simple. The contaminated soil was noted from work done previously by a previous consultant, Ayres and Associates - not from fieldwork done by REI, thus the site merits a soil CO Packet and soil fees along with a NR 726 closure request with a CO Packet.

In summary, a soil only CO packet and NR 726 closure request and associated fees are necessary.

And Mr. Larsen of REI will charge for more time by only talking to Chris and not myself - which is a waste of PECFA funds and of Chris' time.
