Hi Jeff -

The indoor air sampling is required to understand if there's a vapor risk that needs to be addressed immediately (i.e. a temporary air filtration system needs to be installed in the interim as the vapor mitigation system is being designed). As discussed during our meeting, vapors may be entering the building not only from beneath the slab, but also via utilities (the sanitary sewer in particular). Sub-slab vapor samples will provide us with concentrations of vapors accumulating beneath the slab, but won't answer whether vapors are entering via other pathways.

Hi Paul,

The indoor air sampling, sealed sump sampling and sub-slab vapor sampling should be paired as the data is not nearly as useful if collected separately. Favorable indoor air sampling will not allow for delayed sub-slab vapor sampling; the sampling is a requirement under ch. NR 716. If Jeff is able to proceed with sampling and reporting, we can revisit Jeff's financial situation and have DNR possibly move forward with the mitigation design & installation and work toward eventual cost recovery.

I understand that these conditions have existed for over 4 years, however now that we've been made aware of the concentrations we can't ignore the acute TCE risk.


