On November 20, 2023, the Department of Natural Resources (DNR) reviewed your request for closure of the case described above. Remaining Actions Needed

Monitoring Well or Remedial System Piping Filling and Sealing

The monitoring wells MW-1S, 1M, 1D – MW-12 at the site must be properly filled and sealed in accordance with Wis. Adm. Code ch. NR 141. Documentation of filling and sealing for all wells and boreholes must be submitted to Dee Lance on DNR Form 3300-005. To download the form, go online at dnr.wi.gov and search "form 3300-005".

Documentation

 Provide a scoping statement for emerging contaminates in accordance with Wis. Admin. Code § NR 716.07.

When the required actions are completed, submit the appropriate documentation within 120 days of the date of this letter, to verify completion. At that point, your closure request can be approved and your case can be closed.

The submittal of both an electronic and paper copy are required in accordance with Wis. Adm. Code s. NR 726.09 (1). See *Guidance for Electronic Submittals for the Remediation and Redevelopment Program, RR-690* for additional information. To view the document online, go to dnr.wi.gov and search "RR 690".

(BOTW) and RR Sites Map, to provide public notice of remaining contamination and continuing obligations. Information that was submitted with your closure request application will be included on BOTW, located online at dnr.wi.gov and search "BOTW".
