We completed the excavation at Doug's Tire last week. This email provides a field report. More complete documentation will follow when confirmation samples are received.

Depth to fluid was measured in EX-7 (nearby) at 22 feet below grade. This depth is estimated to apply to the entire excavation area.

The excavation went as planned. The excavation area was divided into two main areas. Area A and north half of Area B was excavated first. After this area was excavated and backfilled to about 4 feet below grade, the south half of Area B and all of Area C was excavated.

Area A was excavated to depths of 25 - 27 feet (with clean overburden set to the side). Impacted soils were encountered relatively shallow (10 feet) in the center of Area A and it appears there was a former tank(s) in that area.

Area B was excavated to depths of about 25 feet. Impacted soils were encountered from about 1 foot below grade to depth.

Area C was excavated to depths of at least 20 feet per the Excavation Work Plan. Significant petroleum (gasoline) impacts were detected in these soils (PID > 100) to depth.

The excavation was completed within a few feet of Hwy. 27 (with buried storm sewer along edge). Impacted soils remain along the west side of Area B where a former tank(s) was.

The tonnage was higher than estimated. The total was 1674.62 tons (verbal from landfill). I will send a Change Order for increased tonnage (commodity costs only) when I receive listing from landfill (on Monday).

The excavation was a success. A significant amount of source soils were excavated. This will accelerate natural bioremediation processes.

Thanks for your efforts (e.g., obtaining funding, Offsite Exemption, etc.) to make this excavation happen this year.
