## Carrie.

Here is Chg Order to steam the frozen pipes at Autostop/Dougs. Cost from plumber (Ron Young) in email below.

As we discussed in previous emails, airflow in the pipes is restricted due to frost buildup. Several pipes are frosted shut (e.g., EX-2, EX-5, RW-3) or restricted (M-1).

Normally I would wait until spring thaw but David Swimm requested data comparing SVE discharge versus ground water levels. To obtain this data, we need the pipes thawed.

I will combine the work with a regular site maintenance trip (in next few days if approval is forthcoming).
