EnviroForensics, LLC has complied with the affected property notification requirements of NR 725 pertaining to such notifications needed prior to obtaining site closure status for the former Robinson Cleaners site located at 1838 W. Court Street, Janesville, Wisconsin. The notifications were a modification of the standard notification Form 4400-286 that was approved for use by the Department prior to submittal. All notifications were sent via certified mail or priority mail with signature confirmation as outlined in NR 725.07 (2).

Of the ninety-seven (97) notifications sent, there were thirteen (13) that could not be delivered or did not return a signature. We have attached Table 1 which contains our shipping and receiving summary. We have also attached the signed receipts and undeliverable notice envelopes.

As you can see in Table 1, at least two (2) attempts were made to deliver the notifications after addresses were confirmed, and in some cases three attempts were made later in June with the mindset that some of the property owners may have spent the winter months out of state. We believe that we have more than complied with the requirements of NR 725 and will not be pursuing delivery any further. All undeliverable notifications involved groundwater use restrictions which are somewhat redundant because the City of Janesville supplies potable water and has an ordinance in place that prohibits the possession or construction of private water supply wells.
