Dear Mr. James.

A bid deferment (using Usual & Customary schedule of charges)/variance is being submitted for the subject property located at W8317 County Highway P in Crivitz (Town of Beaver), Wisconsin. The cost estimate will include: [1] Attempt to sample SSVS ports VP-2 and VP-3 as they have had water present in them during the last two sampling events. If VP-2 and VP-3 cannot be sampled there will then be an attempt to seal off the sump and collect a 30-minute vapor sample. If the sump area cannot be sampled properly then a vapor port will be attempted in the north wall of the basement above the water table, adjacent to residual contamination. During this same event, a 24-hour indoor air sample will be collected in the northern portion of the basement along with a 24-hour outdoor air sample. All samples will be analyzed for PVOC and Naphthalene. [2] If in the first event the sub slabs, sealed sump sample, or vapor sample through the north wall cannot be completed a second set of 24 hour indoor and outdoor samples will be required and sampled 1-2 weeks after the first event. This samples will also be analyzed for PVOC and Naphthalene. The cost estimate is as follows:
