On January 31, 2018, the Wisconsin Department of Natural Resources (Department) received a scope of work (SOW) and cost estimate utilizing the chapter NR 747, Wisconsin Administrative Code, Usual and Customary Cost Schedule (Cost Schedule) for the site referenced above.

The Department has determined that the submitted SOW is reasonable and **approves** the additional costs. This site will be deferred from the public bidding process at this time. The Department will contact you if this site will be bid in the future, rounds

This approval is for sampling the entire monitoring well network (PVOC + Naphthalene) for (4) quarterly rounds. Sample (2) private wells (1st round (VOCs); 2nd – 4th rounds (PVOC + Naphthalene). Perform hydraulic conductivity testing on the following wells (MW 1,8,13A, 13B and 14), waste disposal and a letter report upon completion. **For the (2) private wells only: If there are non-PVOC detects for the first sampling round, then continue sampling using VOC Method 524.2 for the remaining rounds. A copy of the Department worksheet for the Cost Schedule tasks is enclosed for your reference.

Be reminded that ch. NR 700 semi-annual progress reporting is required until this case is closed.

Note: A claim for PECFA reimbursement must be submitted within 180 days of incurring costs (i.e., completing a task). If a claim for costs incurred is not submitted within this deadline, the costs will not be eligible for PECFA reimbursement. Usual and customary costs for activities included in this approval will only be reimbursed at a rate equal to or less than what is allowed on the Cost Schedule, and are reimbursed based upon the Cost Schedule that is in effect at the time the activity is performed.
