Carrie, I am preparing for the first post-excavation gw sampling event and noticed that we have PVOC+Naphthalene approved for all the gw sampling events. However, source monitoring well MW-1 has had NR140 ES exceedences for 1,2-DCA and all other wells including the private well have been no detect for 1,2-DCA.

Would it be best to change all the sampling to PVOC+Naphthalene+1,2-DCA or to only sample MW-1R for that analysis and the rest of the wells sample for PVOC+Naph?

Either way a note will have to be added changing all 36 samples or just 4 samples to include 1,2-DCA. Costs for PVOC+Naphthalene are \$30.35/sample and PVOC+Naph+1,2-DCA are \$43.79/sample.

I have the sampling set up for next week Tuesday Feb. 20<sup>th</sup>.
