Per our discussion and your e-mail communication of January 5, 2015, Endeavor Environmental Services, Inc. (Endeavor) is providing the following information as a Bid Deferment for the above referenced site.

Proposed Scope of Work

Endeavor submitted a Site Status Update dated December 20, 2014, detailing the findings of the previously approved Scope of Work. Based upon Department review, site closure has been deemed appropriate at this time.

Endeavor proposes the following closure activities:

- Prepare and submit a Soil and Groundwater Site Investigation Report/Conditional Case Closure Request;
- Prepare and submit a GIS Registry Packet for the source property;
- Investigative waste (purgewater) disposal;
- Abandonment of the monitoring well network.

Endeavor will perform the above outlined activities following the U & C Cost Schedule (#16). Per communication with the WDNR, Cost Schedule #17 will be posted later in 2015.
