Dear Mr. Rogus:

On May 26, 2016, the Wisconsin Department of Natural Resources (DNR) received the status report, submitted by your consultant, REI, for the above-described site. We are not able to provide detailed review and approval because of staffing and workload levels. However, I did give the report a cursory review, and based on DNR guidelines and circumstances specific to this site, the recommendations appear to be a reasonable in this situation with the following comments:

- A short workplan must be submitted within 30 days describing the proposed construction design of the proposed additional wells and sampling.
- Well construction logs for the sprinkler wells must be included in the workplan.
- A site map showing the location of the proposed wells must be included in the workplan.
- A geologic cross section figure that includes the source property and sprinkler wells must be included in the workplan.
- A groundwater sampling plan sufficient to determine if and where additional wells may be needed to fully define the groundwater plume must be included in the workplan.
- A timeline for completing the scope of work and status report submittal must be included in the workplan.

Please be aware that NR 749, Wis. Adm. Code, establishes fees for requested Department review and response actions taken by staff in the Remediation and Redevelopment Program. If you wish to have the Department provide a detailed review of the above-mentioned document, please submit \$700.00 for this service. Please make the check payable to: State of Wisconsin, Department of Natural Resources.

This letter is your **notice to proceed** with submitting the required site investigation workplan. Work should be performed and reported in accordance with Wisconsin Administrative Code. Particularly the NR 700 series on contamination cleanups, and applicable DNR groundwater sampling and remediation technical guidance publications.
