Thank you all for the productive and collaborative discussion this afternoon regarding CWC and the upcoming commissioning testing round for East Block. The bullet points below are an attempt to capture the notable decisions/discussion from the call. Please feel free to add to or revise any of the items if I missed anything:

1) Testing Period - After discussion, we collectively decided on a commissioning testing period of 14 days for both passive samplers and continuous GC testing (primarily in units 1045 and 1050).

- 2) 1st Floor Focus We agreed on moving some of the passive samplers proposed on floors 2 and 3 down to floor 1. The goal is not to be as concerned about specific number of samplers on each floor but to ensure we have the appropriate locations still covered on 2nd and 3rd floors, which includes areas above previous hot spots on level 1 and in stairwells.
- 3) Rain events and weather conditions Although we're hoping that a significant rain event happens during the 14 day testing period, either way CWC will include weather data in the commissioning testing report. The goal is to adequately describe how the system has performed/is performing under heavier water/rain conditions. CWC should also include temperature data (inside and outside) during testing, and information about open/closed windows and patio doors.
- 4) Telemetry It was discussed and understood that telemetry will be installed after this commissioning round, so CWC's reporting on vacuum measurements will look similar to what was done for West Block.
- 5) Interim OM&M The plan and timing for OM&M and closeout should be submitted in the commissioning report for WDNR's consideration and feedback.

Thank you again for the discussion and here's to hoping all goes well in this next round.
