GRO (\$1 \$24.78)
TCLP Lead (\$26 \$83.16)
TCLP Benzene (\$29 \$83.16)

This is additional cost of \$191.10.

I think PECFA Claims will accept an email approval and note in Tracker....shouldn't have to write formal letter.
