We completed the remedial excavation at the former Julson Store site.

We removed an estimated 670 tons. The excavation dug to clean along the south, east, and west sides. There is impacted GW extending under the road (CTH BB) to the north but no Direct Contact issues. We dug to about 12 feet which removed smear zone soils at depth. Excavation was definitely the right option here.

We will install MWs next week (Monday, Tuesday) and sample next week. Our plan is to sample two quarters and then determine if any further work is needed. Our goal is Closure with GIS Registry for Soil and GW.

Yesterday (8-15-18) we continued soil excavation at former Julson Store site.

As you can see from the attached site map and picture, we are reaching the end of the excavation. We have additional soil remaining to be excavated from the northeastern corner of the excavation.

Our tonnage total reached approximately 540 tons at the end of the day yesterday. That leaves roughly 3 loads under the current budget (500 tons original + 100 tons = 600 tons). Today, we began the remedial soil excavation at the former Julson Store site (W125 CTH Z, Mondovi). See attached pictures and site map for reference.

We excavated 250 tons (approx.) of impacted soil today. We plan to return tomorrow to continue excavating impacted soil.

The budget estimate was 500 tons. However, we ran into a couple of issues in the field which may increase the amount of soil that should be excavated.

1. Found 2 tanks

We found 2 tanks (see attached site map and pictures). Advanced Tank assisted with the removal, cleaning, and disposal of the tanks (a 500 gallon and a 750 gallon tank).

The presence of these 2 tanks combined with the tank removed initially (in 1994) explains the significant impacts encountered in the soil borings and ground water.

It is possible we might encounter more tanks (I have seen it before at these old sites).

2. May exceed budget of 500 tons

As you might expect, the soil under the 2 tanks (which had obvious holes) was heavily impacted. The water table is over a foot deeper (due to dry conditions). This allowed us to excavate deeper into the smear zone (to about 14 feet beneath the former tanks)....which was good.

This additional depth produced more soil (tonnage) than planned. At this time, we might be fine with the current budget of 500 tons ...based on field estimates. **But I am requesting approval for another 100 tons** in case we run into more soil. The additional tonnage would be invoiced at unit rates as described in the Change Order.
