I was just assigned recently assigned to this case but have not had an opportunity to review the file. I don't have any direct knowledge of what's happening here other than what is listed in BRRTS on the Web (BOTW):

Based on BOTW, a deed affidavit was filed in 1999 and ownership confirmed in Dec 2015 by one of our limited term employees (LTEs). I will be following up in the coming

months with refreshing this case and working with enforcement to see if we can get some action. However, it looks like all we know about this site is soil contamination from a tank. I will have to review the file in the coming weeks to get more details.

Are there any plans by the city or county for this property that I should know about as I proceed?
