I would be okay with semiannual or annual sampling (at a minimum) initially, unless the Village feels differently. What I would also like to see is a brief status update with where things are at this site. It is my understanding that the Site Investigation is complete and a remedial action needs to be taken. I believe our quarterly reports demonstrate that the sump water consistently meets the Village chemical criteria for the discharge water.

I am hoping we can cut the sampling back to once per year to reduce costs and eliminate unnecessary sampling. While the cost isn't tremendous, it does add up, and it seems the results have consistently been far below the required criteria.

I believe Richard Joslin of the WDNR and the Village will need to modify their requirements to formally allow a reduction in sampling frequency - can that be considered?

Do you need some formal request from us to support that request, or is the provided report and historic data adequate to support a reduction?

Let us know what you need, and if this is a possibility.

All,

Attached is the quarterly sanitary discharge report for the former Dutch Cleaners site in Cedar Grove, WI. The sump was measured and sampled on December 20, 2016.

Going forward, we will continue to monitor and report the sump discharge in order stay in compliance with Village permit. As we discussed in the past, since the sump water contains low levels of PCE it can't be discharged to the ground surface. So even though the sump water is fairly clean, the groundwater is not. The basement sump is only about 8 to 10 feet deep, the water table is about 18 feet down. The groundwater has much higher concentrations, and the DNR will require some type of remedial action to be completed to drop the concentrations prior to closure of the site.
