John,

You are correct that we discussed extending the excavation beneath the building if it is removed. The reason it wasn't included with the final RD is because the building was still standing this fall when the final report was completed. It is still our understanding that Graymont will demolish this building before the remediation will start. They have been contacted several times throughout the fall and they still plan to demo the building. Jamie said the building was still standing a few weeks ago.

Envirocon did complete a couple additional borings late this fall around the building and it demonstrated that the impacts did not extend past the building on the north and northeast sides (downgradient). If the building is demolished before the remediation, SWL&P will instruct Envirocon to excavate under the building footprint using the same field parameters in the rest of the excavation to demonstrate the extents of impacts removed. Confirmation laboratory samples will be collected to demonstrate on the sidewalls and bottom of excavation.

We are starting the process of site access agreements with Graymont and will continue to discuss with them on the schedule and plan for the demolition of the building.

A while back we discussed the plan to demolish the building at the MGP site and SWL&P was planning on excavating the area under the building instead of completing a site investigation. I do not see a discussion of this in the 100% design. If the structural impediment (building) is removed and soil not excavated we need site investigation in this area of the site and probably additional remedial action at a later date. I would think it is preferrable to address contamination beneath the former building now rather than this issue coming up at the time of closure. I do not see a discussion of this in Section 2.6 (Excavation). If I missed the discussion of this in the 100% design please direct me to the section that discusses it.
