On October 2, 2019, you were sent the attached Remaining Actions Needed letter which outlined your outstanding requirements in order to achieve regulatory case closure of the WI DOT Jerrys Union 76, contamination case located at 1200 Roosevelt Road, in Niagara, Wisconsin (Site). The letter stated that you must abandon the monitoring wells at your Site, providing documentation to the Wisconsin Department of Natural Resources (DNR) within 120 days, and submit a cap maintenance plan to address the residual contamination. The DNR is requesting an update on these necessary remaining actions.

Remaining Actions Needed

1 - Monitoring Well Filling and Sealing

The monitoring wells at the site must be properly filled and sealed in accordance with Wis. Adm. Code ch. NR 141. Documentation of filling and sealing for all wells and boreholes must be submitted to Andy James on DNR Form 3300-005 within 120 days. The form can be downloaded online at dnr.wi.gov and search "form 3300-005".

2 - Cap Maintenance Plan

Submit a cap maintenance plan which outlines the required maintenance of the existing impervious surface cover (the asphalt parking lot) to minimize the infiltration of rainwater through the remaining soil contamination.

Documentation

When the required actions are completed, submit the appropriate documentation within 120 days of the date of this letter. At that point, your closure request can be approved and your case can be closed.
