## NOTICE OF NONCOMPLIANCE

On May 16, 2014, I notified you by certified letter (70073020000068293809) of your responsibilities to investigate and, as needed, remediate contamination located at the above-described property. As stated in this letter you have certain legal responsibilities, as outlined in Section 292.11(3), Wisconsin Statutes, also known as the hazardous substances spills law.

To date, the Department hasn't received any information on your choice of an environmental consultant, a site investigation and remedial action scope of work (SOW) plans. Therefore, please submit the following:

- 1. Submit the name of your environmental consultant by July 10, 2015.
- 2. Have your environmental consultant submit a site investigation scope-of-work plan by August 10, 2015.

Failure to respond to this letter in writing will be viewed as an admission that you do not intend to pursue an investigation and remediation of the contamination associated with the site. In that situation, we will recommend further enforcement actions be initiated. Enforcement actions could include the recording of an affidavit at the Milwaukee County Register of Deeds Office indicating contamination remains, while at the same time issuing an administrative order, or making direct referral to the State Attorney General's Office to recoup our costs, and any associated fees that may have been due. Any referral to the State Attorney General's Office could result in forfeitures.
