1. Who installed the well?
2. Who was suppose to be maintaining the well?
3. Was an association ever set up?

Our Drinking and Groundwater Program is looking into these issues as well. Everyone involved seems to think the gas station was providing maintenance and upkeep on the well for 3 years, then residents were to set up an HOA to take over maintenance – I cannot find any record of this. It likely would have occurred between 2005-2009. I have a report of Steve's Plumbing that installed the well but doesn't look like they did anything more than that.
